2019 LECC/SCLEOA Narcotics Commanders School

August 5-9, 2019



The Law Enforcement Coordinating Committee (*Office of U. S. Attorney*) South Carolina Law Enforcement Officers' Association, and LECC Drug Subcommittee in conjunction with South Carolina Criminal Justice Academy

will host a four and one-half day school *for supervisors of narcotics units*. This course is designed to help narcotics supervisors manage a narcotics unit and to provide experienced narcotics commanders as well as new and potential commanders with an understanding of challenges and management issues in managing narcotics units in the 21st century. Attendees will receive practical information and tips from experienced narcotics commanders and other law enforcement practitioners serving as instructors. The class also provides information on current drug trends as well as an understanding of the benefits of working with state and federal agencies and potential resources these agencies have available to local law enforcement.

Eligibility:	First-Line Supervisors of Narcotics Units <u>or</u> officers who are expected to be promoted into a narcotics supervisory position within the next two years—Lieutenant or higher rank. (NOTE: Students are selected by the LECC Drug Subcommittee to attend this class. Four alternates will also be selected; therefore, agencies do <u>not</u> have the option to substitute officers if it is necessary for a selected officer to cancel.)
CLASS SIZE:	Twenty-eight (28) participants

Officers and their supervisors will receive notification of selections via e-mail before the end of May.)
