did within this county and state on or about 1/2/2025 violates the criminal laws of the

State of South Carolina (or ordinance of [X] County/ [] Municipality of Greenville)

in the following particulars:

DESCRIPTION OF OFFENSE: Breach / Breach of peace, aggravated in nature

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

THE DEFENDANT, DURING A LAWFUL TRAFFIC STOP, DID CONVEY TO THE AFFIANT THAT HE HAD A SMALL BOMB IN HIS 18 WHEELER TRUCK, KNOWING THE INFORMATION TO BE FALSE, IN AN ATTEMPT TO INTIMIDATE THE AFFIANT, A SOUTH CAROLINA STATE TRANSPORT OFFICER. THE ACTIONS OF THE DEFENDANT DID CAUSE INTERSTATE 85 TO BE COMPLETELY SHUT DOWN FOR SEVERAL HOURS WHILE THE TRUCK AND SURROUNDING AREA WAS COMPLETELY SEARCHED BY BOMB SQUAD TECHNICIANS. THESE ACTIONS BREACHED THE PEACE OF HUNDREDS, IF NOT THOUSANDS, OF TRAVELERS AND RESIDENTS IN NEAR PROXIMITY TO THE INCIDENT. THIS OFFENSE OCCURRED IN GREENVILLE COUNTY, SC.
