Body-Worn Camera and In-Car Video Camera Grant Program Application



****Application Period March 17, 2025 – May 1, 2025****

Body-Worn Camera (BWC) Grant Program

WHO IS ELIGIBLE?

Per SC Code of Law 23-1-240, all state and local law enforcement agencies, the Attorney General's Office, solicitors' offices and public defenders' offices may apply for BWC Program Funds.

WHAT DOCUMENTATION DO I NEED?

Documentation must include: quotes, invoices, purchase orders, and other purchase documentation. Law Enforcement agencies must include BWC policy and approval letter from the South Carolina Law Enforcement Training Council (SCLETC) before the application is considered complete.

WHAT IS ALLOWABLE WITH BWC AWARD?

State Fiscal Year 2026 BWC Grant Program Funds can be used to purchase BWC's, equipment, maintenance and/or storage. **Reimbursement requests for previous purchases are allowed. Purchases must have occurred between July 1, 2024 – June 30, 2025.**

LAW ENFORCEMENT PROFESSIONALS LEGAL PROFESSIONALS

The application is online at www.scdps.intelligrants.com. Agencies will have to review and complete the Applicant Training Video before registering for a username and password. Once approved, all users will have access to a training materials link.

In-Car Video Camera (ICVC) Grant Program

WHO IS ELIGIBLE?

Per SCDPS Proviso 63.8, all state and local law enforcement agencies may apply for funding, with priority given to those law enforcement agencies who prioritize DUI enforcement activity.

WHAT DOCUMENTATION DO I NEED?

Documentation must include: quotes, invoices, purchase orders, and other requested documents.

WHAT IS ALLOWABLE WITH ICVC AWARD?

State Fiscal Year 2026 ICVC Grant Program Funds can be used to purchase ICVC's, equipment, maintenance and/or storage. **Reimbursement requests for previous purchases ARE NOT eligible with the ICVC Program.**

The application is online at www.scdps.intelligrants.com. Agencies will have to review and complete the Applicant Training Video before registering for a username and password. Once approved, all users will have access to a training materials link.

The completed application must be submitted by the scheduled **deadline of 5:00 PM on Thursday, May 1, 2025.**
Applications received after 5:00 PM on May 1, 2025, will not be considered for funding.
