INTRODUCTION

Hitting Close to Home is designed to provide basic statistical information about domestic violence in South Carolina. The scope of this report is limited to information that was available from crime incident reports. As a result, it does not provide data from other important sources related to domestic violence such as court outcomes, criminal history, community supervision or corrections. It does contain important information concerning the nature of the offense and provide descriptive information concerning the victims and offenders involved in domestic violence. It is intended to provide this information in a manner that is readily and easily understandable. In doing so, it is hoped that this report will be useful not only to policy makers and practitioners but also to the citizens of this state.

COUNTING DOMESTIC VIOLENCE

These notes are intended to provide a brief overview of how data on domestic violence are collected and how they were brought together to form this report. They are not intended to provide a comprehensive description of crime reporting methods, but rather seek to give the reader a working knowledge of the uses and limitations of crime data and how that data can be used to better understand the extent and nature domestic violence.

All the information presented in this report starts with the statewide uniform incident report. This report is filled out whenever a criminal incident is reported to the police. The responding officer fills out the report that contains detailed information about the incident, the victim and the offender. This information is entered into the South Carolina Incident Based Reporting System (SCIBRS) database, which is maintained by the State Law Enforcement Division (SLED). SCIBRS is the source of crime data for this report. This report is based on crime reports from the calendar years 1996, 1997, 1998, 1999 and 2000. Because SLED provides a two-year window for law enforcement agencies to edit/correct their reports, the data for 2000 were not in their final format for this report. All rates are expressed in terms of rate per 10,000 units of the population of interest. Population data were provided by the South Carolina Budget & Control Board, Office of Research and Statistics (B&CB ORS).

Domestic violence can be defined in a variety of ways. For the purpose of this report, broad definitions of both violence and domestic relationships were used. It is important to note that these definitions are subjective and are used only for the purpose of this report. Other definitions of domestic violence may be equally appropriate under other circumstances.

Definitions:

Domestic relationships were defined to include marital relationships (spouses and common law spouses), family relationships (parents, siblings, children, grandparents, grandchildren, in-laws, stepparents, stepchildren, stepsiblings and other family members), romantic relationships (boyfriends, girlfriends and homosexual relationships) and ex-spouses.

Violence was defined to include the following: murder, negligent homicide, justifiable homicide, rape, robbery, aggravated assault, forcible sodomy, sexual assault with an object, forcible fondling, simple assault, intimidation, and kidnapping. Justifiable homicide was included because it provides an additional indicator of violence, although it is not a criminal offense.

Some aspects of SCIBRS result in information that is counter-intuitive and requires further explanation. The information in this report is based on counts of victims or offenders. However in reviewing this report it is important to understand the following:

- Domestic violence victims are sometimes victims of more than one offense:
- Domestic violence sometimes involves more than one victim or more than one offender.

One result of this is that the number of offenses exceeds the number of victims. Also, data from such victims would be presented more than once in the course of this report. For example the victim data from a domestic murder and rape would be included in the section on murder as well as in the section on forcible sex offenses. Another result is that the number of victim to offender relationships can exceed the number of victims. This happens when there are multiple offenders with different domestic relationships to the victim, such as a spouse and a family member. This also results in data from the victim being presented in both the marital violence and family violence sections. This method of presenting the information was chosen to maximize the usefulness and understanding of the report.

Finally, while a certain level of detached objectivity is required when conducting statistical analysis on any topic, it is important to be ever mindful that the tables, charts and narrative in this report represent pain and suffering inflicted by those from whom love and comfort was expected. These are facts that can never be accurately expressed by words or numbers.

DOMESTIC VIOLENCE

There were 132.9 victims of domestic violence per 10,000 people in South Carolina from 1996 through 2000.



Domestic Violence Victimization by Year




Simple assault was the most frequently reported violent domestic offense. There were 540 domestic homicides.



Domestic Violence by Relationship





Annual Domestic Violence Injuries





Domestic Violence by Weapons



Domestic Violence by Location







Domestic Violence by Day of Week













Domestic Violence Victimization Rates by Race/Sex



Domestic Victims by Ethnicity











Domestic Violence Offender Rates by Race/Sex







Domestic Murder Victimization Rate by Year



Domestic Murder by Relationship





Domestic Murder Circumstances





Domestic Murder by Weapons





Domestic Murder by Month



Domestic Murder by Day of Week







Domestic Murder Victimization Rate by Age











Domestic Murder Offender Rates by Age













Domestic Forcible Sex Offense Victimization Rates







Domestic Forcible Sex Offenses by Injury









Domestic Forcible Sex Offenses by Month





Domestic Forcible Sex Offenses by Day of Week







Domestic Forcible Sex Offense Victimization Rates by Age













Domestic Forcible Sex Offender Rates by Age

















Annual Domestic Aggravated Assault Injuries



























Domestic Simple Assault/Intimidation Victimization Rate by Year







Domestic Simple Assault/Intimidation by Location







Domestic Simple Assault/Intimidation by Day of Week













Domestic Simple Assault/Intimidation Victimization Rate by Race/Sex





















































Family Violence by Victim/Offender Relationship













Family Violence by Day of Week







Family ViolenceVictimization Rate by Age





Family Violence Victims by Sex





Family Violence Victims by Race





Family Violence Victimization Rate by Race/Sex











Family Violence Offender Rates by Race/Sex



Family Violence Offenders by Ethnicity





Annual Violence Rate in Romantic Relationships









Annual Injuries From Violence in Romantic Relationships





Violence in Romantic Relationships by Weapon







Violence in Romantic Relationships by Day of Week





















Violent Offenders in Romantic Relationships by Race/Sex





IMPLICATIONS FOR FUTURE RESEARCH

It would be difficult to summarize such extensive findings as are contained in this report in a concise, meaningful way. However, there are key findings that have important implications for future research that should be noted. The startlingly young age of domestic forcible sex offense victims compared to other offense category victims is one such finding. This report is inadequate in addressing several questions that leap to mind. What is the relationship between these very young victims and the offenders? Where and when does victimization take place? To what degree does substance abuse play a role in this sort of victimization? These questions could be addressed with further SCIBRS data, however other important questions remain that would require other data sources. What happens to the offenders that are convicted, in terms of sentence and treatment? If the offenses occur within a family relationship, what measures are taken to prevent future victimization?

The findings regarding ethnicity also have implications for future research. The lack of reported Hispanic domestic violence victims and offenders, combined with the degree to which ethnicity was reported as unknown raises concerns that underreporting might be a problem. This could occur for a variety of reasons, cultural differences, language barriers, or an inability on the part of law enforcement to accurately identify ethnicity. It is also possible that the data are relatively accurate in respect to ethnicity, but the degree to which ethnicity is reported as unknown is an area of concern.

Further study of the role of substance abuse in domestic violence could serve to clarify the extent to which it contributes to violent domestic behavior. While it is clear from SCIBRS data that drug and alcohol use plays a role in domestic violence, for both offenders and victims, more in-depth study from other data sources is needed to better understand what that role might be. Questions regarding the degree of dependence, specific substances and the relationship between offender and victim substance abuse would have important policy and programmatic implications.

Other findings present compelling arguments for further investigation. The disproportionate over-representation of racial minorities in the criminal justice system is an area of abiding concern. Research in this area, beyond the scope of SCIBRS data to identify additional factors associated with this over-representation is important. The degree to which females are disproportionately represented as victims of domestic violence is a crucial area of continuing concern. Research to identify risk and protective factors is essential for the development of proactive prevention policies. The high rate of violent behavior by within families and the high rate of domestic forcible sex offenses by teenagers highlights another area of concern, and one that certainly warrants further research.

Perhaps the most important implications for future research are those that cannot be addressed with the SCIBRS data. The degree to which the data in this report represent a repetition of behavior by a smaller group of chronic domestic violent offenders cannot be discerned from these data. Similarly, SCIBRS data are insufficient to determine if domestic violence tends to escalate from relatively minor offenses such as intimidation and simple assault to the more serious offenses such as aggravated assault and murder, or if the more serious offenses simply occur unpredictably.

Most importantly, systematic inquiries into the problem of domestic violence should continue. Hopefully, the use of SCIBRS data for the analysis of domestic violence will continue and expand, and data from other sources will be used to increase our understanding of domestic violence. An accurate, reliable and comprehensive body of knowledge concerning domestic violence is vital if policy makers are to have a factual basis from which to combat this deadly problem.
