#### **INTRODUCTION**

By Force and Without Consent: A Five Year Overview of Sexual Violence in South Carolina 2008 – 2012 is part of a series of ongoing reports, designed to provide basic information about victims of sexual violence over a five year period. The information presented in the tables, graphs and charts in this publication is based on incident reports submitted to the South Carolina Law Enforcement Division (SLED) by state and local law enforcement agencies. These reports are edited and reviewed, corrected as needed and compiled to form the basis of the information presented in this report. It is important to note that the information in this report is only as complete and accurate as the information reported to local law enforcement and subsequently submitted to SLED. While there are a variety of legal and social definitions of sexual violence, this report uses a broad definition of sexual violence, parsed into meaningful sub-categories, in order to provide as much useful information as possible. Particular emphasis has been placed on providing information that might not otherwise be readily available at the local level, with the intent of providing local decision makers with policy relevant information concerning domestic violence. Towards that end, in addition to the state level information, the report provides a section containing county rankings for a variety of measures of domestic violence and as well as a section containing victimization trends and victim profiles for each of the state's forty-six counties.

We wish to express our thanks and appreciation to the sheriffs, chiefs of police, state and local law enforcement officers and administrative staff that provide the data upon which this report is based. The difficult work involved in gathering, reviewing and submitting crime and arrest data, in addition to the primary responsibility of responding to crime, makes publication of this report possible. It is also important to note that publications such as this would not be possible without the ongoing and active assistance of SLED's Crime Information Center. The report itself is a product of the South Carolina Department of Public Safety, Office of Highway Safety and Justice Programs Statistical Analysis Center; funded in part by the United States Department of Justice, Bureau of Justice Statistics.

#### COUNTING AND DEFINING SEXUAL VIOLENCE

These notes are intended to provide a brief overview of how information concerning sexual violence is collected and compiled. They are not intended to be a comprehensive description of crime reporting methods, but rather are intended to give the reader a working knowledge of the uses and limitations of crime data and to provide an understanding of how this information can be used to describe the nature, extent and associated trends of sexual violence in South Carolina.

Data from the South Carolina Incident Based Reporting System (SCIBRS) provides the basis of this report. The SCIBRS data collection process starts with the submission of an Whenever a criminal event is reported to law enforcement, the incident report. responding officer fills out an incident report which contains detailed information about the incident, the victim, the offender along with information related to any associated arrests. A great deal, though not all, of this information is subsequently forwarded to SLED, entered into SCIBRS and maintained for future use. It is important to be aware that analysis of SCIBRS data will often vary from other published crime rates and counts for a variety of reasons. Chief among these is that SCIBRS data allows for the flexibility to use whatever unit of count (victim, offense, offender, arrestee, etc.) is most appropriate. The unit of count used throughout this report was victim, however there are nuances associated with the use of some factors that can result in different totals. These conditions are noted and explained, as succinctly as possible, throughout the report. SCIBRS also has the capacity to allow analysis beyond the use of only the most serious offense, unlike many published crime reports, particularly those relying on summary crime data. SCIBRS collects a great deal of information from these incident reports, including information concerning the circumstances and nature of the incident, demographic characteristics of victims, the type of injuries suffered by victims and the relationship between the victim and the offender. SCIBRS data from 2008 through 2012 provided the basis of crime data for this report. All of South Carolina's sheriff and police departments reported crime incidents to SCIBRS during the time period covered by this report. With minor, intermittent exceptions, SCIBRS has had full statewide participation dating back to 1991. SCIBRS is fully compliant with the requirements of the Federal Bureau of Investigations' National Incident Based Reporting System (NIBRS). Augmentations designed to meet state specific needs have expanded the scope of SCIBRS beyond the minimum requirements of NIBRS.

It is also important to note the limitations of SCIBRS data. First and foremost, SCIBRS is restricted to reported criminal incidents. The very nature of unreported crime excludes such incidents. To provide some notion of the scale of non-reporting, a national report relying upon victimization survey data concluded that slightly more than one-quarter of rape and other sexual assaults were reported to law enforcement in 2012 (Truman, et.al., 2013). It is also important to understand that SCIBRS is a "stand-alone" system, lacking personal identifiers for any individuals involved in an incident. This limitation means that questions involving the prior record or subsequent involvement of individuals involved in sexual violence cannot be addressed using SCIBRS data nor can SCIBRS

data records be linked to data records from other data sets, such as criminal history records, in an effort to address such questions.

Sexual violence was defined as an incident in which one of the following offenses was reported against an individual: rape, forcible sodomy, sexual assault with an object and forcible fondling. Victimization rates were calculated using the equation below:

Victimization Rate =  $\frac{\text{Number of Victims}}{\text{Population (or sub-population)}} \times 10,000$ 

In December 2011, the FBI approved revisions to the definition of rape. The revised (current) definition of rape is penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. The current definition includes victims of forcible sodomy, victims of sexual assault with an object and male victims. The intent of this revision was to develop a more accurate understanding of the scope and volume of these crimes. Unfortunately, it is not possible to apply this new definition to rape totals from previous year (SLED & SCDPS, 2014). To allow accurate comparisons over time, the historical definition of rape was used throughout this report.

The County Rankings and County Five Year Trends & Profiles sections provide information regarding victims of sexual violence and victimization trends for each county in the state. While the intent is to provide the most detailed level of information as possible, it is important to consider the information in the proper context. The reader should be aware that small numbers can sometimes magnify annual trends or aspects of victim profiles beyond their actual importance. For example, if the number of victims changes from two to four from one year to the next, that represents a 100% increase. However, that large percentage increase is based on a very small number of victims and in reality may not represent a drastic change. Victimization rates in counties with small populations are subject to seemingly large changes that are the result of small changes in the number of victims. Similarly, the implications for a county in which a very high percentage of the victims of sexual violence are children might differ based on the total number of victims. If the total number of victims is small, change might be the result of a minor fluctuation in the numbers. If the total number of victims is substantial, then an observed change might be viewed quite differently. While this report seeks to include as much information as possible, it is important that the reader be mindful of such pitfalls. In the end, statistical information is no substitute for critical review and considered judgment.

State and county population estimates used to calculate victimization rates were provided by the South Carolina Revenue and Fiscal Affairs Office (RFA). The sum of categories for tables, charts and graphs may not total 100% in some cases due to rounding.

# **STATEWIDE FIVE YEAR OVERVIEW**

#### Forcible fondling and rape were the most frequently reported sexual violence offenses. Forcible fondling accounted for 42.9% of violent sex offenses, rape accounted for 42.1%.


**SEXUAL VIOLENCE:** Sexual violence consists of the offenses of rape, forcible sodomy, sexual assault with an object and forcible fondling.

#### Other crimes were involved in 5.1% of violent sex incidents. Kidnapping was the offense most often reported in addition to violent sex offenses. Kidnapping was reported as part of 3.1% of violent sexual victimizations.

**OTHER OFFENSES:** SCIBRS records up to five offenses per victim. Offenses other than those defined as sexual violence are sometimes committed and reported in the same incident involving violent sex offenses.



# Offenses Associated with Sexual Violence 2008 - 2012





# Sexual Violence by Time of Day 2008 - 2012




The time of day pattern of victimization was different for children and adults. Child victimization peaked at midnight, but also spiked at 8:00 AM, noon and 3:00 PM. Sexual violence against adults increased steadily during the evening hours, peaked at midnight and decreased gradually through the early morning hours.

# Sexual Violence by Time of Day Comparing Children and Adults 2008 - 2012





# Sexual Violence by Day of the Week 2008 - 2012





#### The most frequently reported type of injury inflicted upon victims of sexual violence was minor injuries. Two deaths (murders) were associated with sexual violence.





# Sexual Violence Victimization by Sex 2008 - 2012









# Sexual Violence Victims by Race 2008 - 2012









# Sexual Violence Victimization by Ethnicity 2008 - 2012




Sexual violence victims were residents of the responding jurisdiction in 80.3% of victimizations. Only 3.6% of victims were from out of state.

Victims who knew the offender but did not have a family, marital or romantic relationship accounted for 50.2% of sexual violence victims. Victims in a family relationship with the offender ranked second, accounting for 25% of sexual violence victims.





























# SUMMARY

Indicators of sexual violence victimization in South Carolina showed both increases and decreases from 2008 to 2012. Overall, the state's sexual violence victimization rate decreased 1.2% over the five year period. The invasive sexual violence victimization rate increased 2.1%, and the forcible fondling victimization rate increased 1.8%. The rate of sexual violence against all children increased 1.8% from 2008 to 2012. However, looking in detail at the specific age groups among children, the victimization rate for children four years old or younger increased 36%, the victimization rate among five to nine year old children increased 21.9%, the victimization rate among ten to fourteen year olds decreased 5.1% and the victimization rate among fifteen to seventeen year olds decreased 8.1%. Among adults, the sexual violence victimization rate decreased 4.9%. The rate of sexual violence victimization rates involving victim to offender relationships where the victim and offender knew each other but did not have a family, marital or romantic relationship decreased 6.8% and the sexual violence victimization rates involving strangers decreased 40%.

From 2011 to 2012, indicators of sexual violence also had a mixed pattern of increases and decreases but with more increases than decreases. From 2011 to 2012, the sexual violence victimization rate increased 1.2%, the invasive sexual violence rate increased 4.3% and the forcible fondling victimization rate increased 2.9%. From 2011 to 2012, the rate of sexual violence victimization increased 4.2% among all children, increased 8.4% among children four years old and younger, increased 21.1% among children from five to nine years old, decreased 5.1% among children from ten to fourteen years old, but increased 1.5% among children fifteen to seventeen years of age. Sexual violence victimization among adults remained the same from 2011 to 2012. Looking at victim to offender relationships, sexual violence among family members increased 9.5%, sexual violence where the victim and offender knew each other but did not have a closer relationship decreased 2.4% and sexual violence involving strangers decreased 14.3%.

There were notable differences in the demographics of sexual violence victimization, particularly regarding victim age, race, sex and ethnicity. More victims of sexual violence were White than Non-White (62.8%); however the sexual violence victimization rate among Non-Whites was 14.9% higher than the victimization rate among Whites. Hispanics comprised 3.8% of sexual violence victims and the sexual violence victimization rate among Non-Hispanics was 18.2% higher than the victimization rate among Hispanics. It is important to mindful that linguistic barriers, legal issues and cultural differences might have a confounding effect upon reporting rates for sexual violence among the state's Hispanic population. Age and sex proved to be especially important demographic factors, factors that seem crucial to understanding patterns of violent sexual victimization. Children (seventeen years of age or younger) accounted for 63.1% of sexual violence victims and the sexual violence victimization rate among children was 6.5 times the sexual violence victimization rate among adults. Women and girls accounted for 85.2% of sexual violence victims, while men and boys accounted for 14.8% of victims. The sexual violence victimization rate among females was 5.4 times the victimization rate among males. Girls from fifteen to seventeen years of age experienced the highest sexual violence victimization rate, 52.3 per 10,000, of any

sex/age group, closely followed by girls from ten to fourteen years of age who had a victimization rate of 50.5. The next highest victimization rates were among girls five to nine years of age with a sexual violence victimization rate of 28.7 and women from eighteen to twenty-four years of age with a rate of 23.2 per 10,000. The sexual violence victimization rate among girls was 35.9 per 10,000. By way of comparison, the sexual violence victimization rate was 7.1 and among men the sexual violence victimization rate was 0.4 per 10,000. It is noteworthy that while girls and young adult women were at the highest risk of sexual violence, boys, particularly those younger than fifteen years of age, also constituted a vulnerable population.

Sexual violence was reported most frequently late at night (midnight) but also spiked during the day at eight o'clock in the morning, noon and three o'clock in the afternoon. However the time of day patterns for sexual violence victimization was different for children and adults. Adult victimization occurred infrequently during the daylight hours with small spikes at eight o'clock in the morning and noon, then increased gradually throughout the evening hours, peaked at midnight and gradually declined during the early morning hours. By way of contrast, among children the time of day pattern of sexual violence included daytime spikes that were much larger than those that occurred among adults. Among children, spikes in violent sexual victimization occurred at several times: midnight, eight o'clock in the morning, noon and three o'clock in the afternoon. Victimization dropped off, sometimes dramatically, after each of these spikes in victimization. It is possible that the daytime spikes in child victimization might be related to activities and behaviors associated with school or day care attendance such as leaving home and going to school, eating lunch, participating in unsupervised activities during the lunch-hour and going to day care or returning home after school.

Victim age was also associated with different patterns of the victim's relationship with the attacker. While both children and adults were most frequently victimized by someone they knew but with whom they had no family, marital or romantic relationship, there were important differences in the nature of victim to offender relationships between adults and children. Adults were victimized most often by someone they knew, secondarily by strangers and much less frequently by family members. Children were victimized most often by someone they knew, secondarily by family members and much less frequently by strangers. While "stranger danger" cannot and should not be dismissed as an important element of protecting children, the analysis suggests that violent sexual victimization by a stranger is a much greater problem for adults than it is for children and that children are much more likely to be attacked by people known to them and family members than by strangers.

The geographic pattern of sexual violence is difficult to characterize in a meaningful way. From 2008 to 2012, twenty-two counties experienced increases in the sexual violence victimization rate and twenty-four counties experienced decreases their rates. At the same time, sixteen counties experienced increases in the invasive sexual violence while twenty-eight experienced increases and two counties' rate remained the same. The forcible fondling rate increased in twenty-four counties, decreased in twenty counties and remained the same in two counties. The demographic profiles of sexual violence victims varied greatly among the counties. The real value of the county level data is to provide a starting point for more detailed analysis at the local level. Similarly, the county rankings provide worthwhile information, but must be understood within the context of local practices and conditions. Counties differ demographically, culturally, in terms of the availability of resources, in the ways in which local law enforcement officials respond to sexual violence reports and in any number of other ways which might have an impact on the degree to which sexual violence occurs or is reported. County population is another factor which must be considered when examining county trends and rankings. Small changes in the number of sexual violence victims in counties with comparatively small populations can result in seemingly (and perhaps deceptively) large changes in the victimization rates and have an inordinate impact on county rankings. Nonetheless, the county level sexual violence information is both important and useful. The five year trends, the data tables profiling sexual violence victims and the county rankings furnish policy makers and the public with useful information concerning the scope and nature of sexual violence at the county level, information which would not otherwise be readily available. Additionally, the report's county level information provides a starting point for more detailed analyses by local stakeholders, who are in a better position than others to understand the influence of local practices and conditions upon sexual violence.

The implications of this report for future analyses are considerable. Although SCIBRS data provides an important tool for better understanding certain aspects of sexual violence, it is an insufficient tool to achieve an in-depth understanding. SCIBRS is limited to information about the criminal event and specific demographic characteristics of the victims, offenders and arrestees involved. At a minimum, information concerning the criminal and mental health histories of violent sex offenders is required, as well as any other factors such as alcohol/substance abuse history that might be related to sexual violence is required. Unfortunately, SCIBRS lacks the identifying information for the individuals involved in the incident needed to successfully link it to datasets containing Past efforts have demonstrated that case identifiers are that sort of information. insufficient for complete matching of SCIBRS to criminal history records (Bradberry & McManus, 2010). Although reliance on of criminal history records as a stand-alone data source on sexual violence would result in the loss of important information concerning the nature and circumstances of the offense that is only available from SCIBRS, that approach provides the only possibility of linking violent sex offenders to other datasources relying on individual identifiers. Further efforts focused on linking SCIBRS with criminal history records, particularly the identification of subsets within which adequate case to case matching can be made, are also needed To the degree such subsets can be identified, further linking to datasets with individual identifiers, without losing the detailed information available in SCIBRS, might be accomplished. Additional SCIBRS based analysis would also be useful. What factors or circumstances are associated with the time of day spikes related to child victimization? SCIBRS could be used as a means of identifying those incidents as the first step in a detailed case study analysis. Determining why these time spikes occur is essential to designing measures to prevent those victimizations.

Finally this report serves to highlight the importance of achieving a better understanding of the role of age in sexual violence victimization. Children, particularly girls, are the primary targets of sexual violence. There are important differences between sexual violence against children and sexual violence against adults and these differences have important implications for education and prevention efforts. Children are at the greatest risk of victimization at midnight, but also tend to be victimized at specific daylight hours that may be related to patterns associated with school or day care schedules. Adults are at the greatest risk of victimization at night and in the early morning hours. Any effective preventive measures must tailor their approach to account for these facts. Adult victimization is much different from child victimization in terms of the victim to offender relationship. While both groups are most frequently attacked by someone they know, adults are sometimes victimized by strangers but rarely victimized by family members. Children are at a much higher risk level for sexual attacks by family members than by strangers. Any effective preventive or educational initiatives would have to be aware of and take into account these differences concerning the most likely offender groups. Although girls are the most frequent targets of sexual violence, boys experienced a higher rate of sexual violence than adult women and the victimization rate for younger boys was much higher than the rate for older boys. Effective preventive, protective and educational measures need to take these age/sex related differences into account. Understanding these complexities is an absolute prerequisite for any realistic efforts to address and reduce sexual violence.
