INTRODUCTION

By Force and Without Consent: A Five Year Overview of Sexual Violence in South Carolina 2004 – 2008 is intended to be an ongoing report, and is designed to provide basic information about victims of sexual violence in the state over a five year period. The information presented in the tables, graphs and charts in this publication is based on incident reports submitted to the South Carolina Law Enforcement Division (SLED) by state and local law enforcement agencies. These reports are edited and reviewed, corrected as needed and compiled to form the basis of the information presented in this report. It is important to note that the information in this report is only as complete and accurate as the information reported to local law enforcement and subsequently submitted to SLED. By their very nature, unreported crimes cannot be included in the report. While there are a variety of legal and social definitions of sexual violence, this report uses a broad definition, parsed into meaningful sub-categories, in order to provide as much useful information as possible. In something of a departure from previous reports intended to provide information concerning the scope and nature of crime and associated trends at the state level, the emphasis of this report has been placed on providing information on short term trends and county level information.

We wish to express our thanks and appreciation to the sheriffs, chiefs of police, state and local law enforcement officers as well as the administrative staff whose hard work in gathering and submitting crime and arrest data to SLED made publication of this report possible. It is also important to note that publications such as this would not be possible without the ongoing and active assistance of SLED's Crime Information Center. The report itself is a product of the South Carolina Department of Public Safety, Office of Justice Programs Statistical Analysis Center; funded in part by the United States Department of Justice, Bureau of Justice Statistics.

COUNTING AND DEFINING SEXUAL VIOLENCE

These notes are intended to provide a brief overview of how information concerning sexual violence is collected and compiled. They are not intended to be a comprehensive description of crime reporting methods. Rather they are intended to give the reader a working knowledge of the uses and limitations of crime data and provide an understanding of how this information can be used to describe the nature, extent and associated trends of sexual violence in South Carolina.

Data from the South Carolina Incident Based Reporting System (SCIBRS) provides the basis of this report. SCIBRS data starts with the statewide uniform incident report. An incident report is filled out whenever a criminal event is reported to law enforcement. The responding officer fills out the incident report which contains detailed information about the incident, the victim and the offender as well as any associated arrests. This information is then entered into SCIBRS, which is maintained by SLED. Analysis of SCIBRS data will often vary from published crime rates and counts for a variety of reasons. Chief among these is that SCIBRS data allows for the flexibility to use whatever unit of count (victim, offense, offender, arrestee, etc.) is most appropriate. The unit of count used throughout this report is that of victim; however there are nuances associated with some factors that can result in different totals. These situations are noted throughout the report. Additionally, edits, updates and corrections are made over a two-year period in order to provide agencies with the maximum window of opportunity to report as fully and accurately as possible. As a result, totals from a specific year can subsequently vary from previously published totals for that same year. Any data published here concerning figures for prior years supersede those published in previous reports. It is also important to be aware that SCIBRS does not restrict analysis to use of the most serious offense, as is often the case with reported crime rates. SCIBRS data from 2004 through 2008 provides the primary source of crime data for this report. The sum of categories for some tables, charts or graphs may not total 100% due to rounding.

Sexual violence was defined as an incident in which one of the following offenses was reported against an individual: rape, forcible sodomy, sexual assault with an object and forcible fondling. Victimization rates were calculated using the equation below:

$$\text{Victimization Rate} = \frac{\text{Number of Victims}}{\text{Population (or sub-population)}} \times 10,000$$

State and county population estimates used to calculate victimization rates were provided by the South Carolina Budget and Control Board, Office of Research and Statistics (ORS).

STATEWIDE OVERVIEW OF SEXUAL VIOLENCE

Rape was the most frequently reported sexual violence offense, accounting for 43.1% of sexual violence offenses.

SEXUAL VIOLENCE: Sexual violence consists of the offenses of rape, forcible sodomy, sexual assault with an object and forcible fondling.

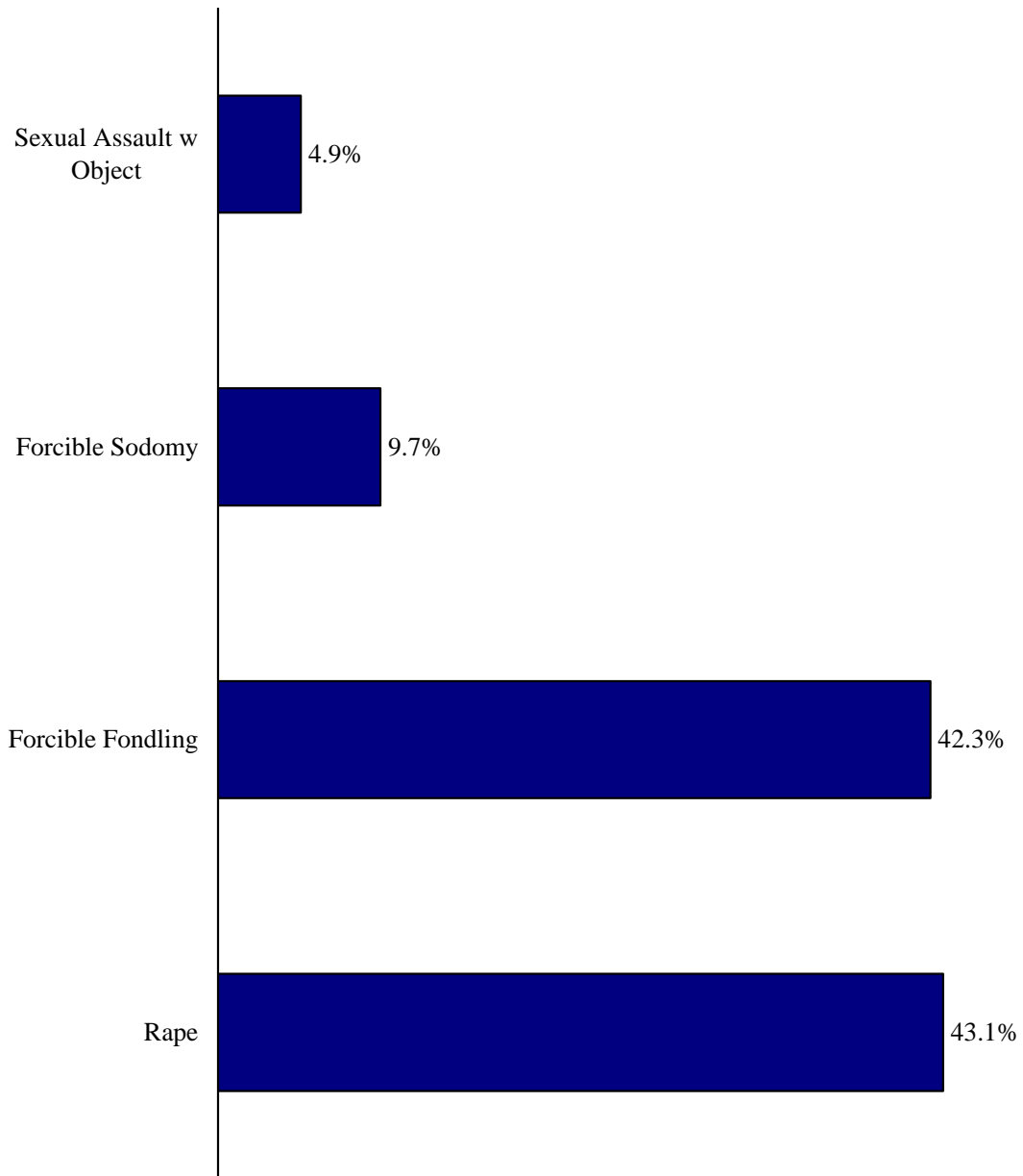

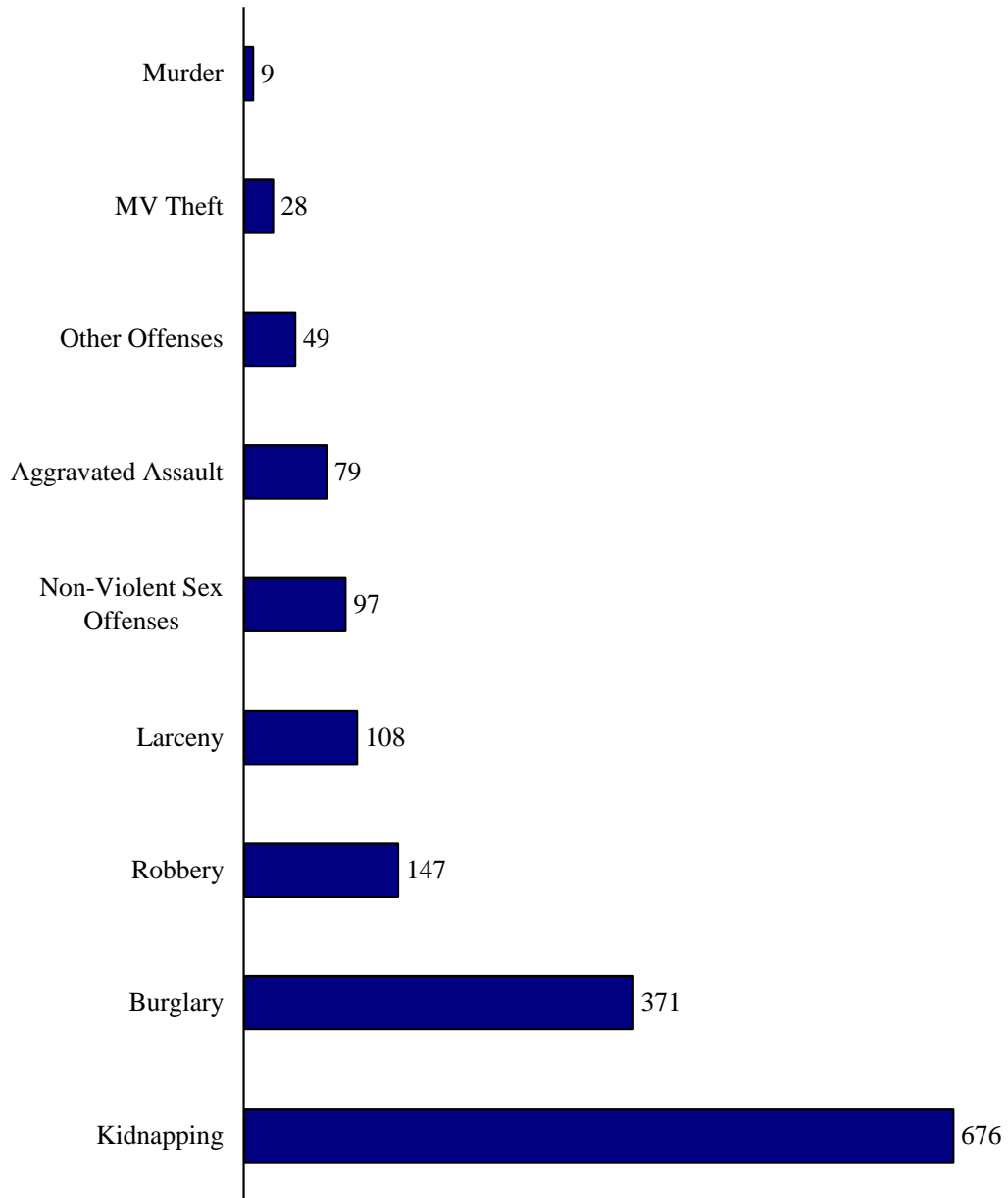

Offenses Associated with Sexual Violence 2004 - 2008



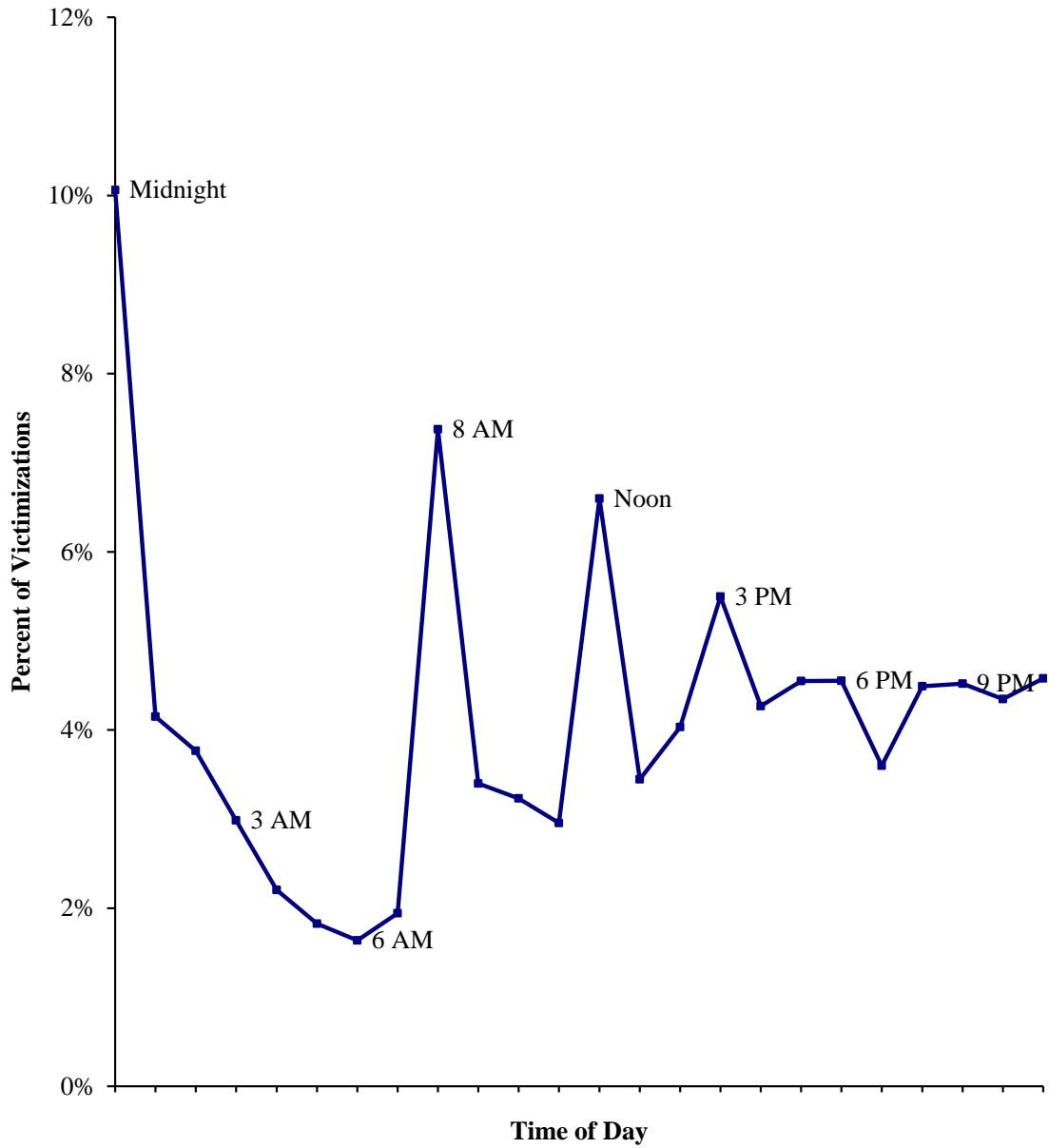

The pattern of victimization by time of day was different for children and adults. Victimization of children was most frequent at midnight, but also peaked at 8:00 AM, noon and 3:00 PM. Sexual violence against adults increased steadily during the evening hours, peaked at midnight and decreased gradually through the early morning hours.

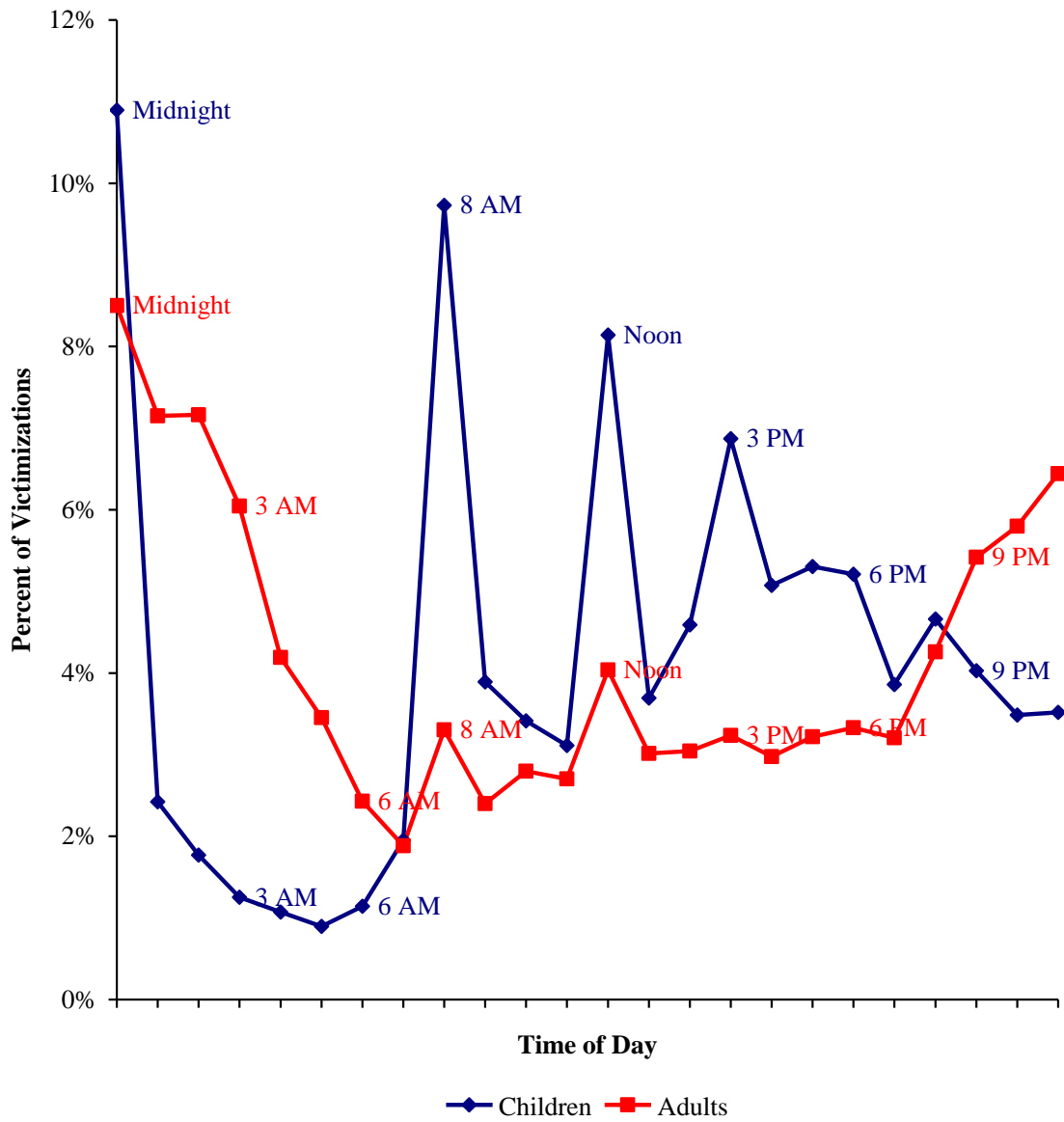

Sexual Violence by Time of Day by Victim Age 2004 - 2008



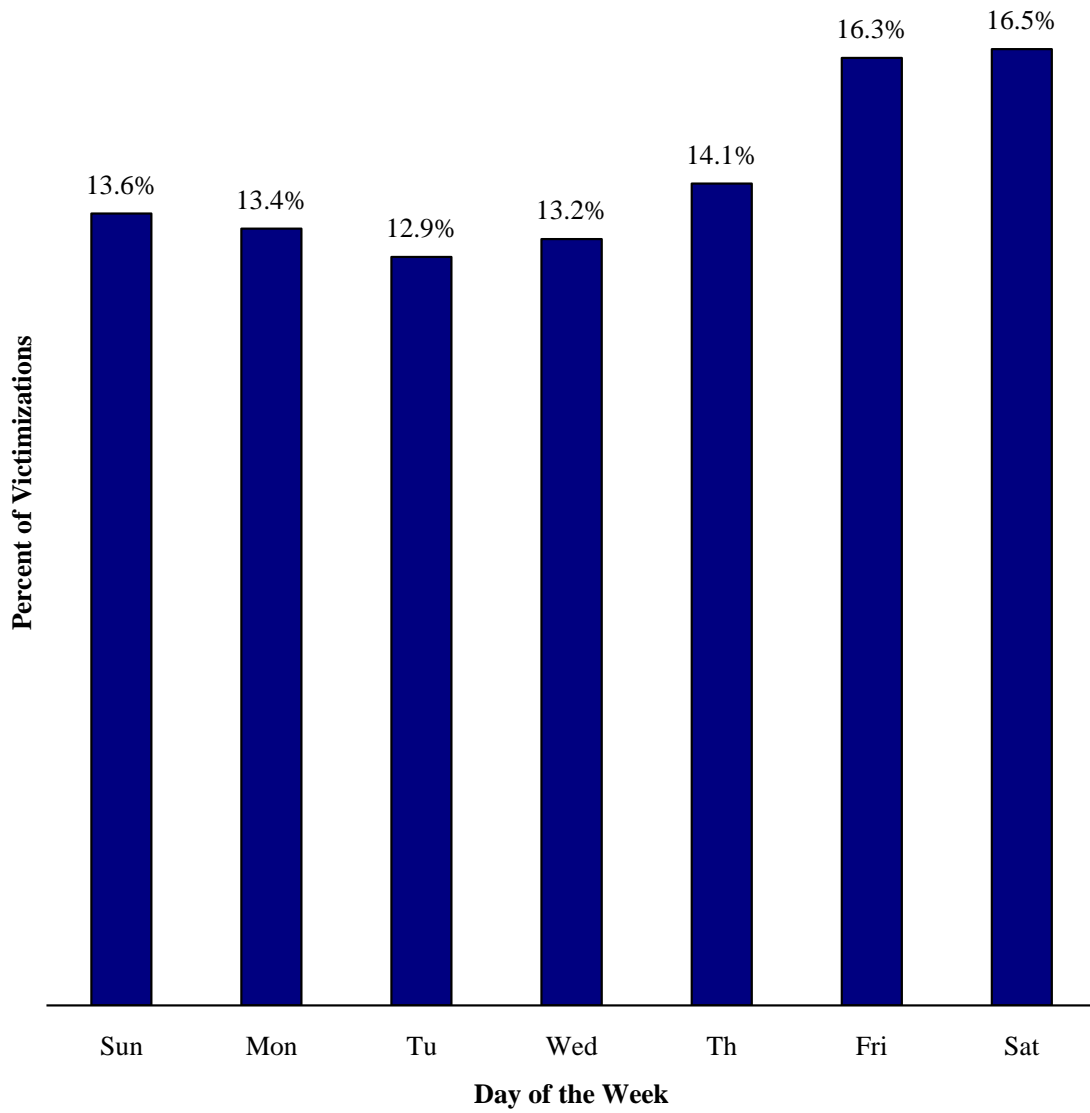

Sexual Violence by Day of the Week 2004 - 2008



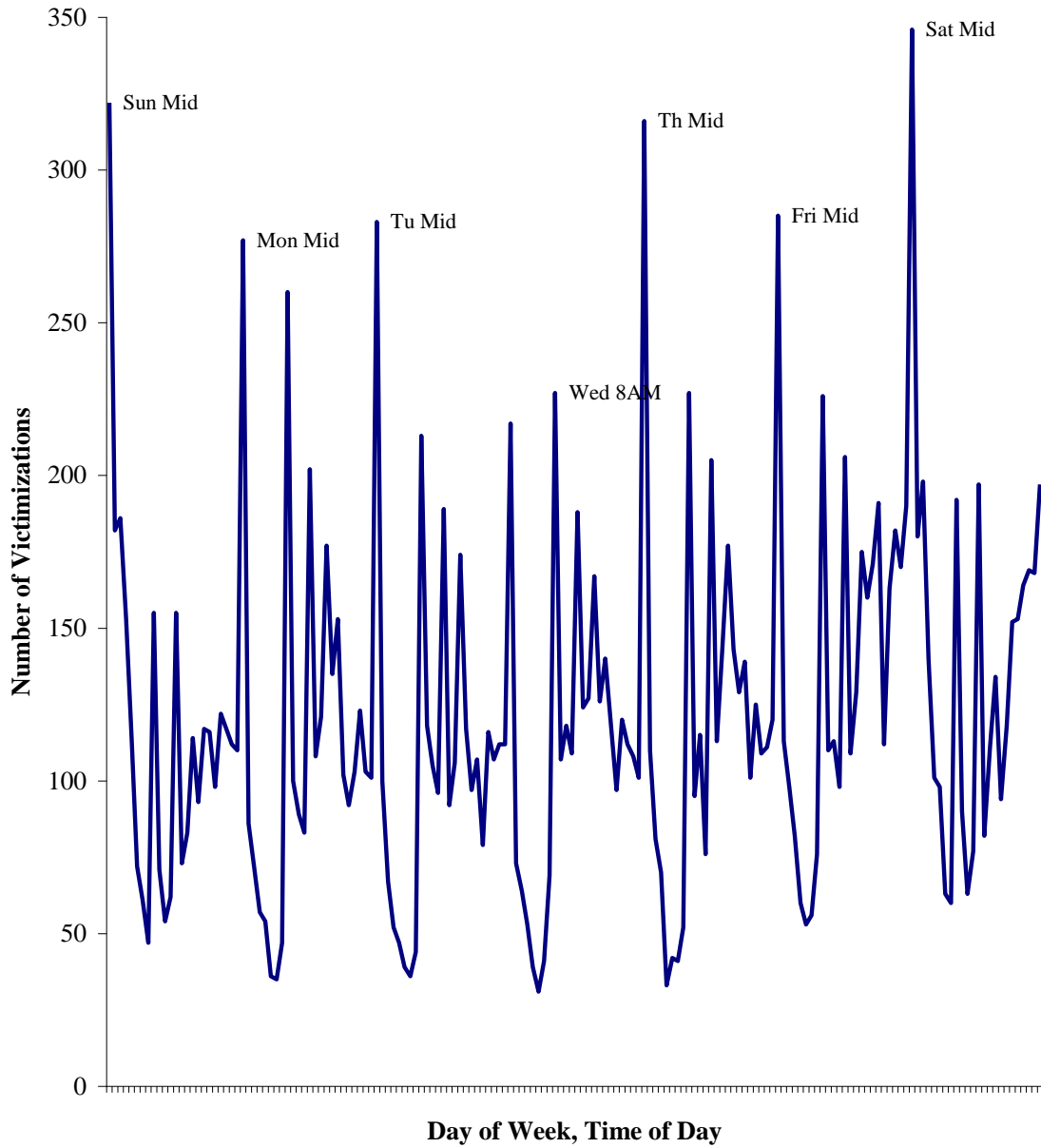

The most frequently reported injury inflicted upon victims of sexual violence was minor injuries. There were 9 deaths reported.

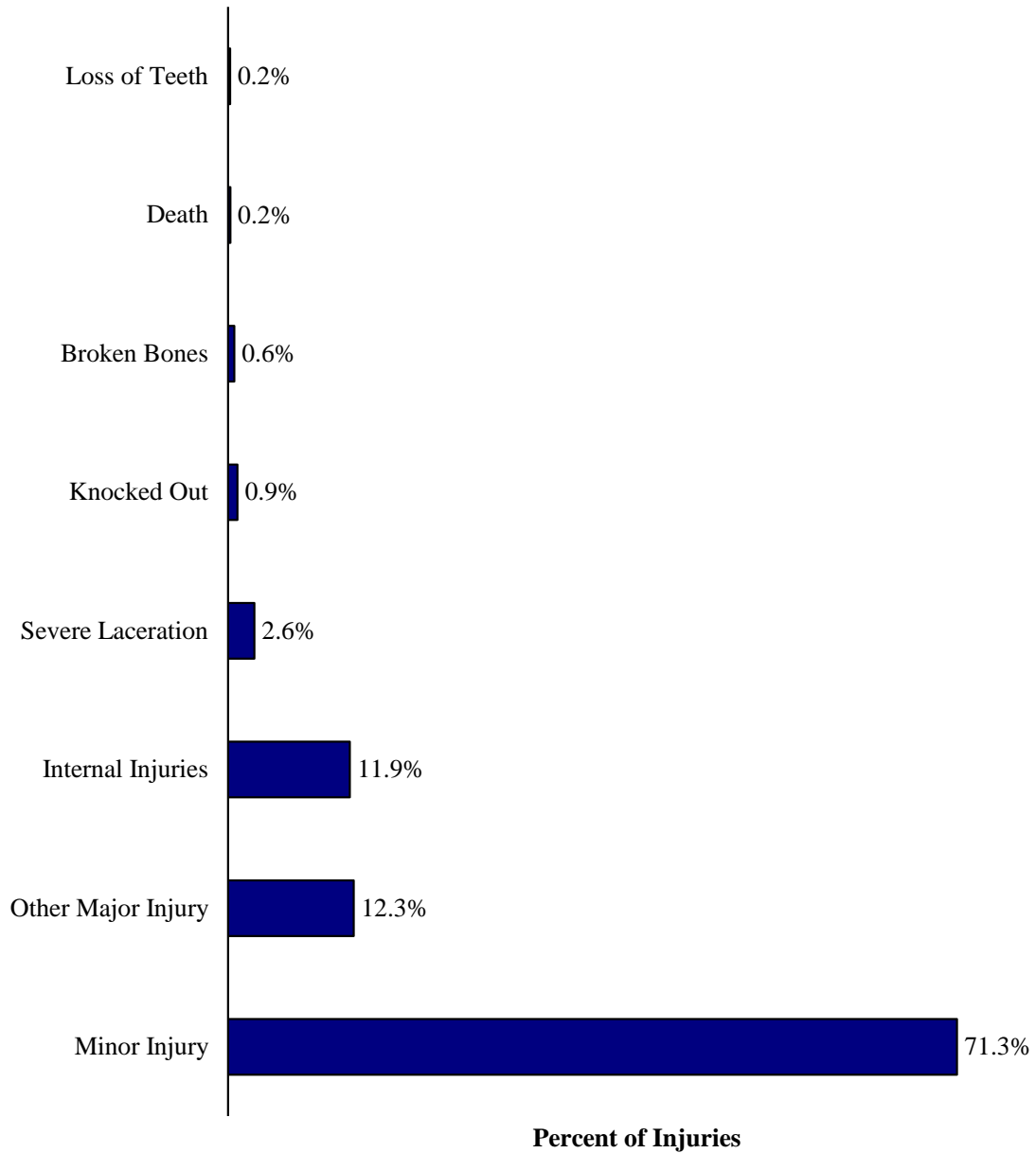

Sexual Violence Victimization Injuries 2004 - 2008



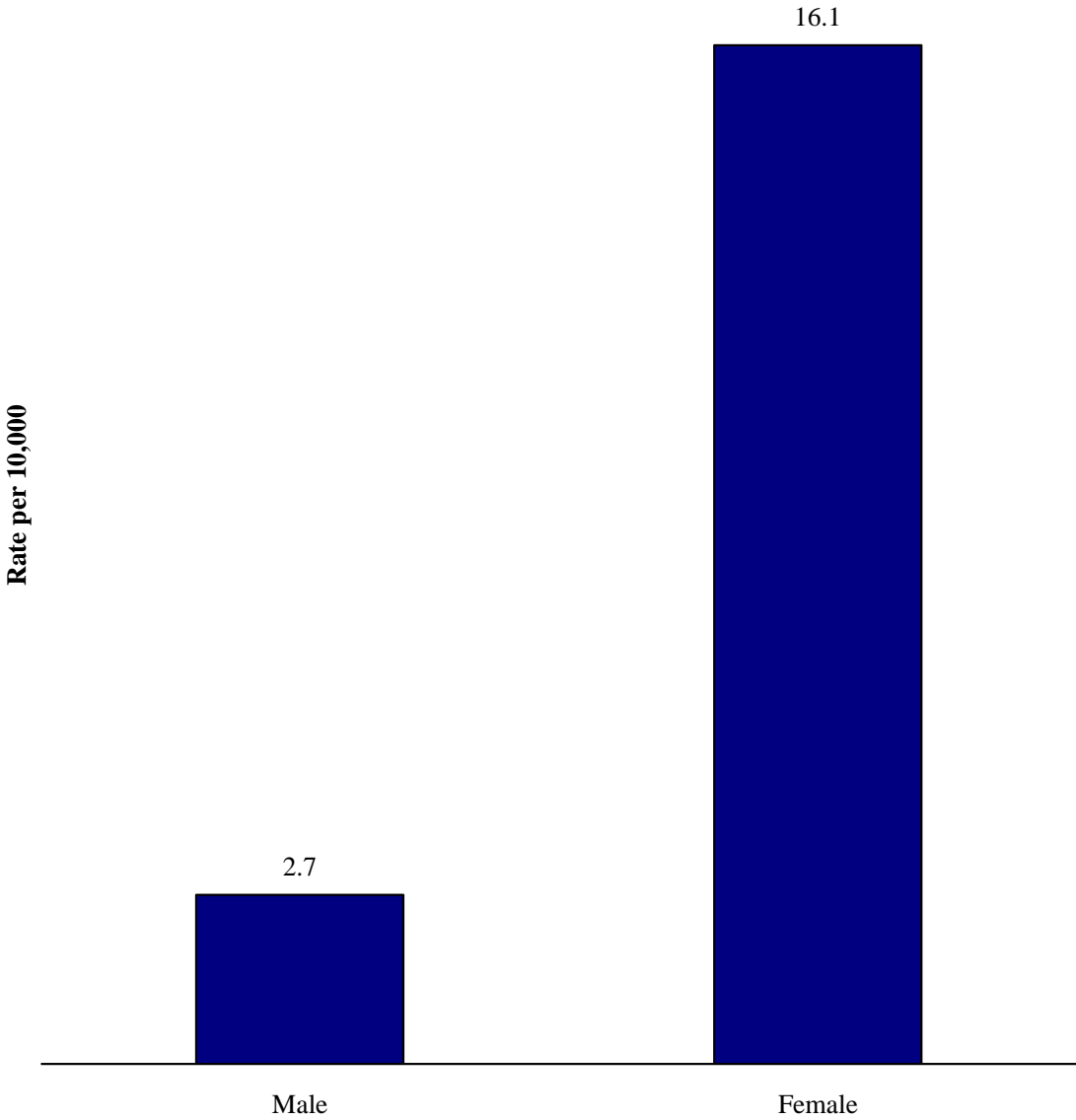

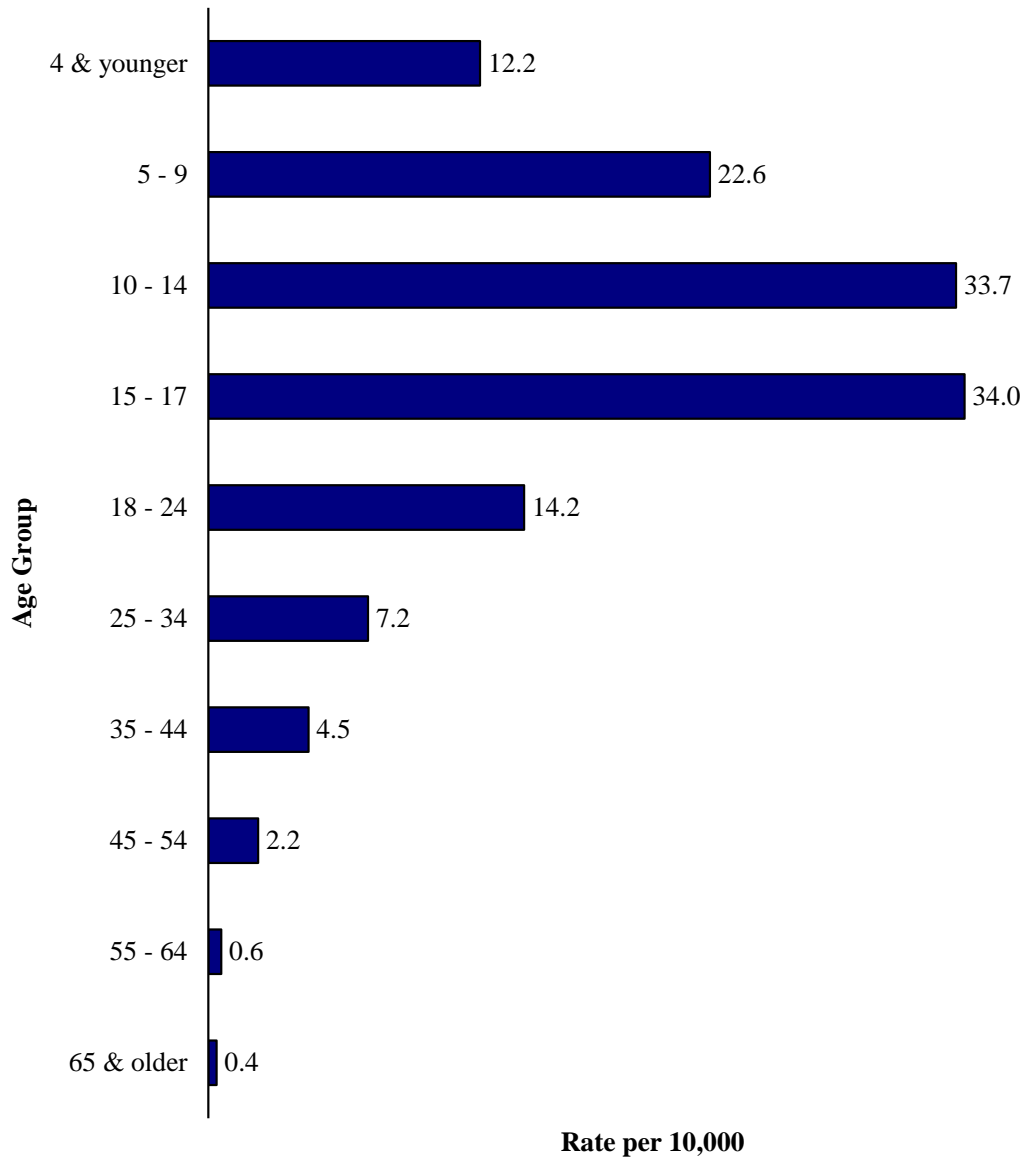

The highest sexual violence victimization rate was among girls from 15 to 17 years old, followed by girls from 10 to 14 years of age.

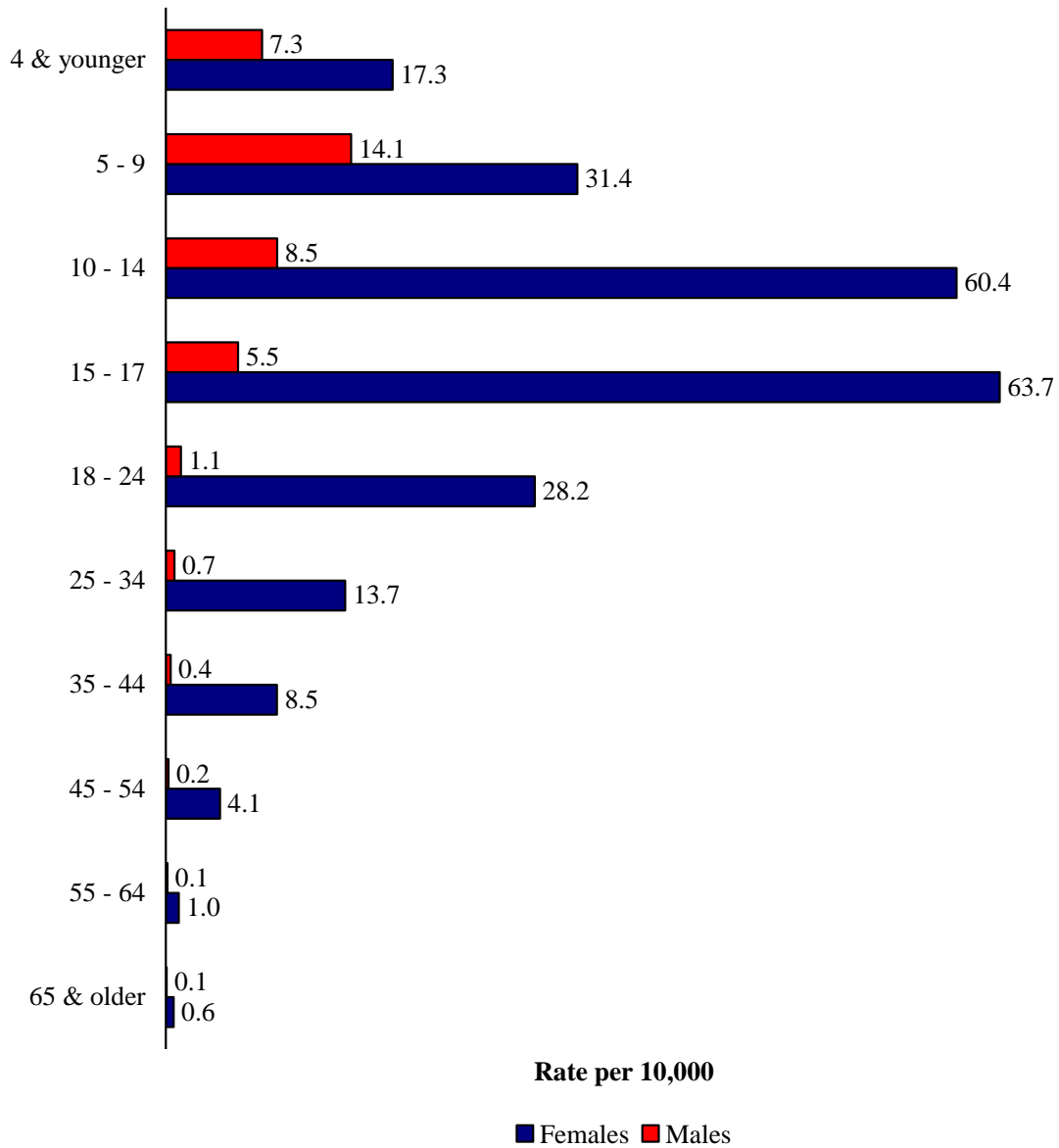

Whites accounted for 62.6% of sexual violence victims, Blacks accounted for 36.6%.

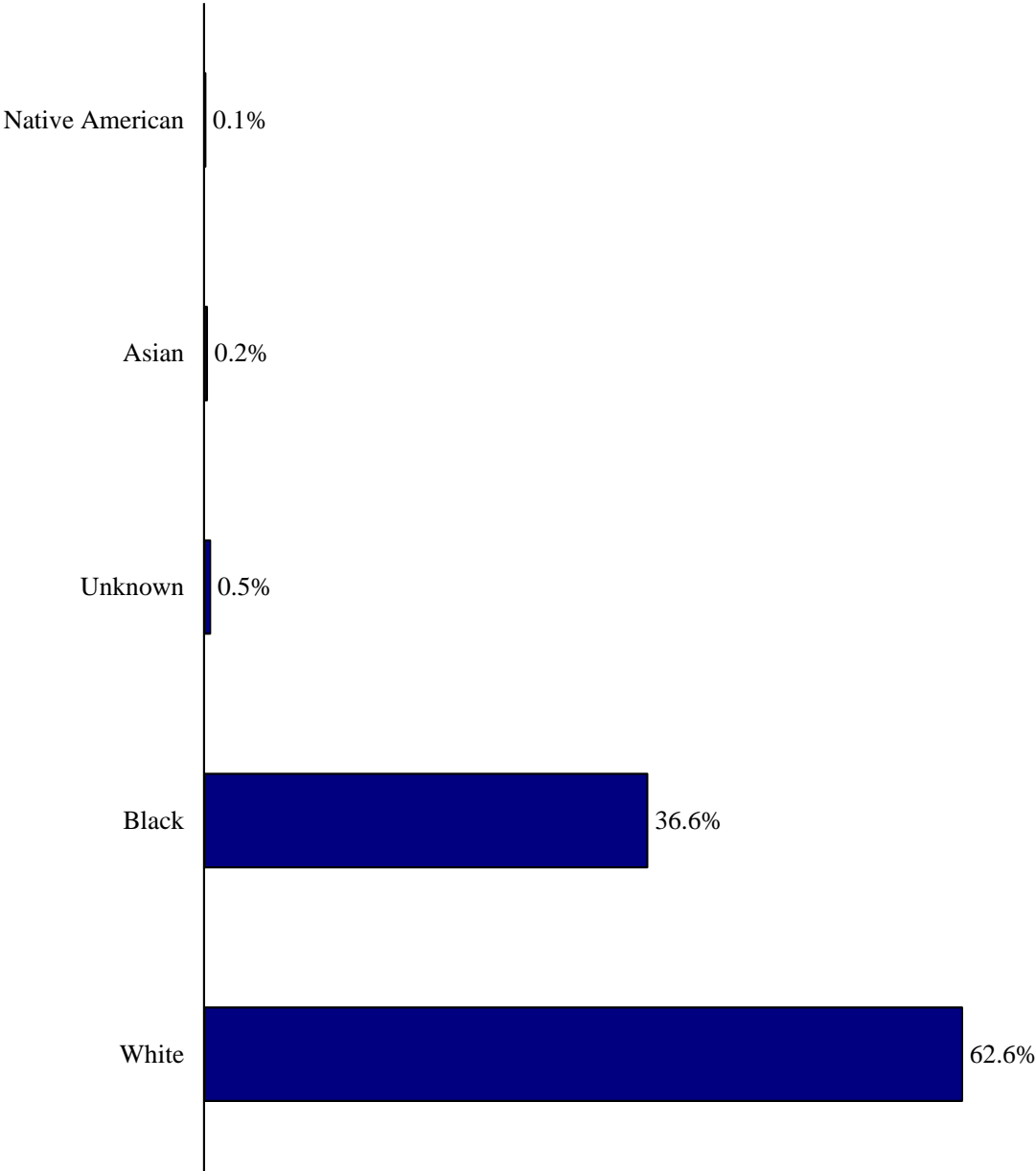

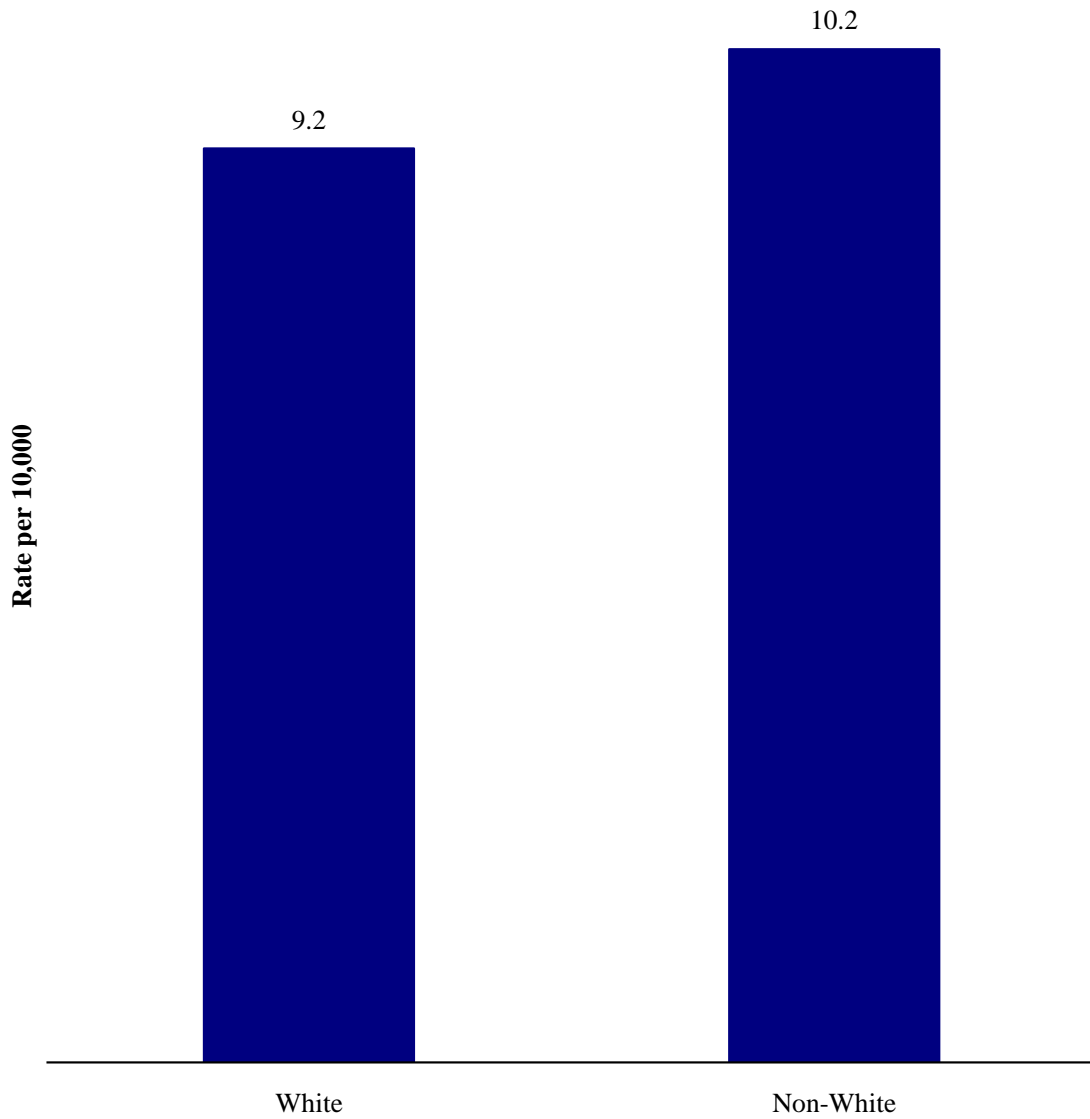

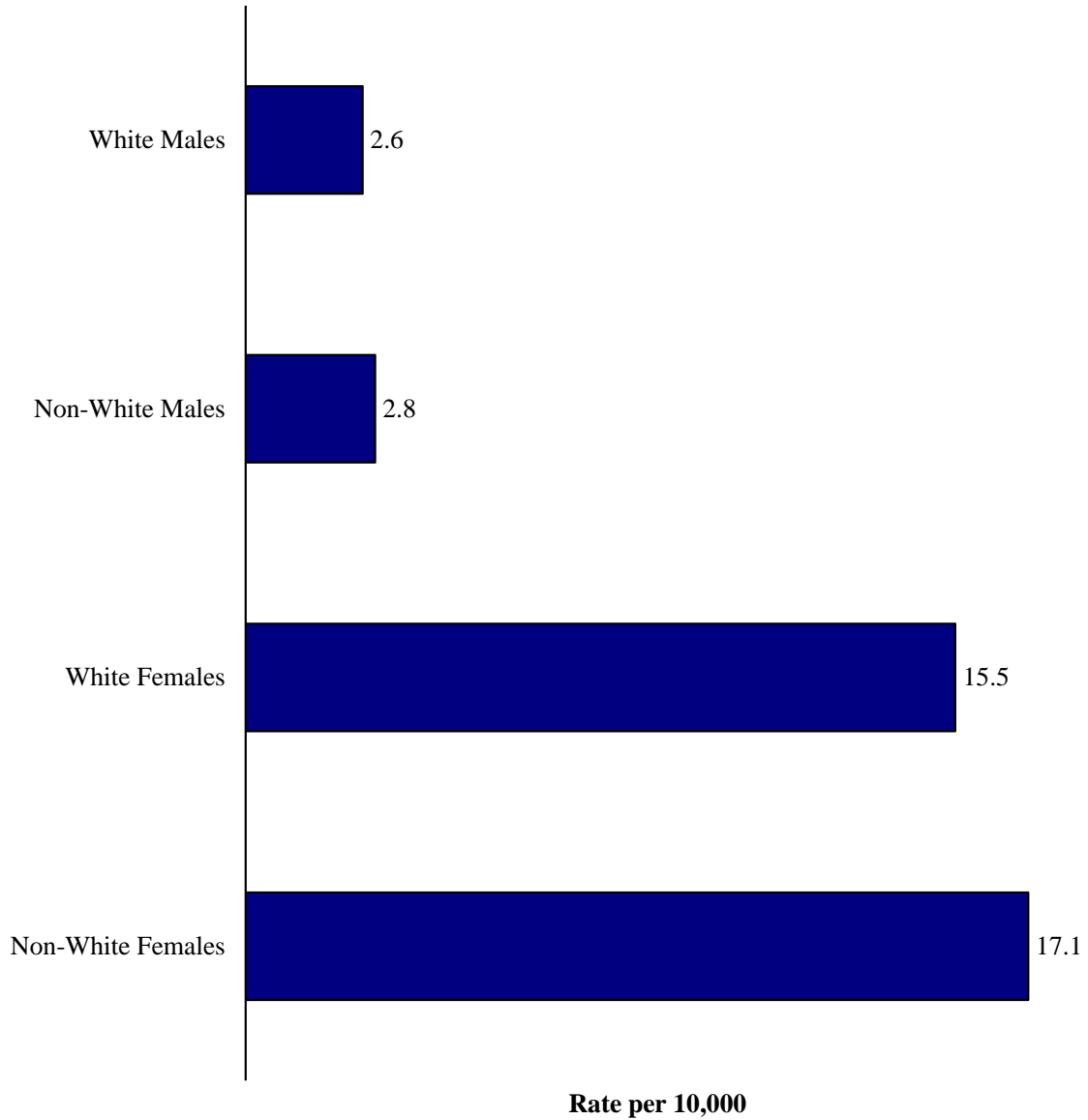

ETHNICITY: SCIBRS categorizes ethnicity into two groups: Hispanic and Non-Hispanic. SCIBRS measures ethnicity separately from race. As a result, a victim of sexual violence is classified into both a racial category and an ethnic category.

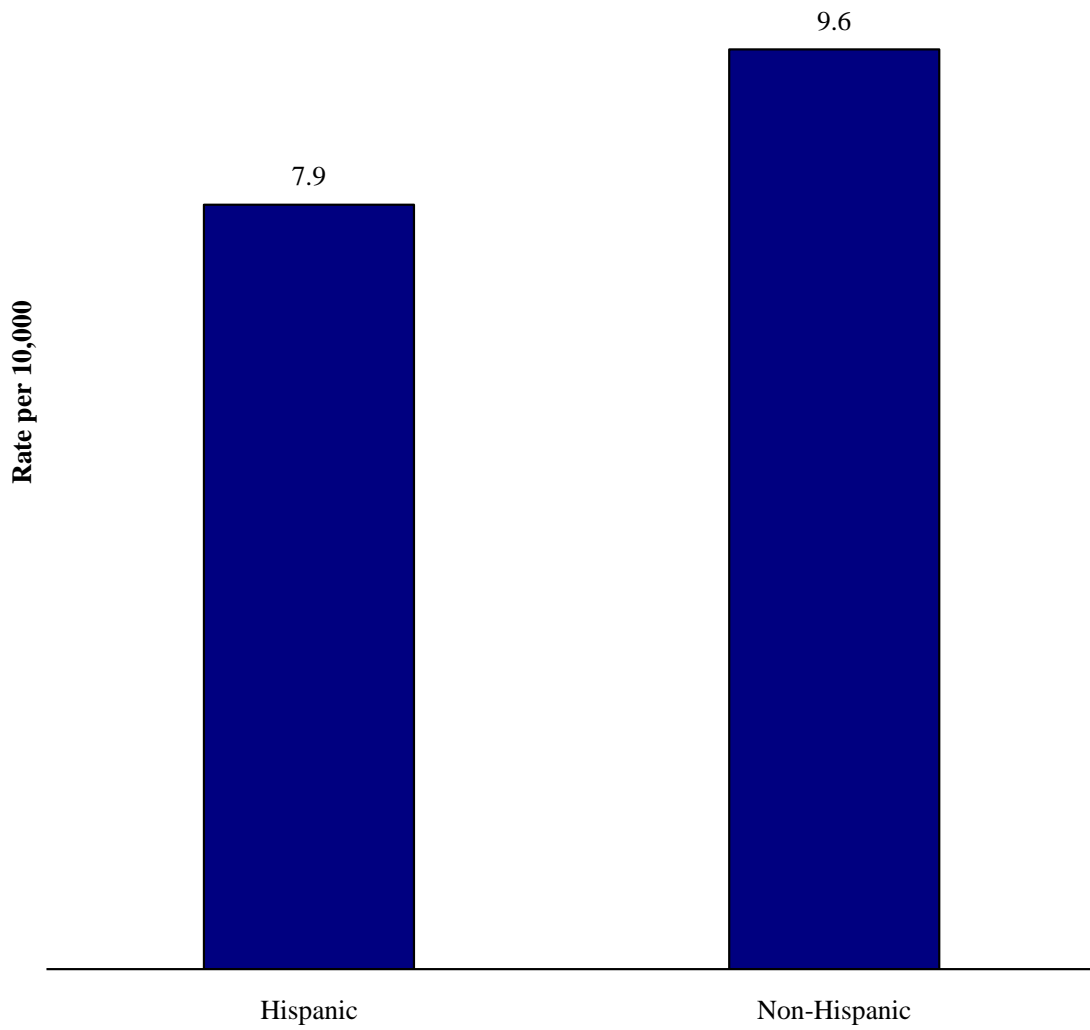

Sexual Violence Victimization by Ethnicity 2004 - 2008



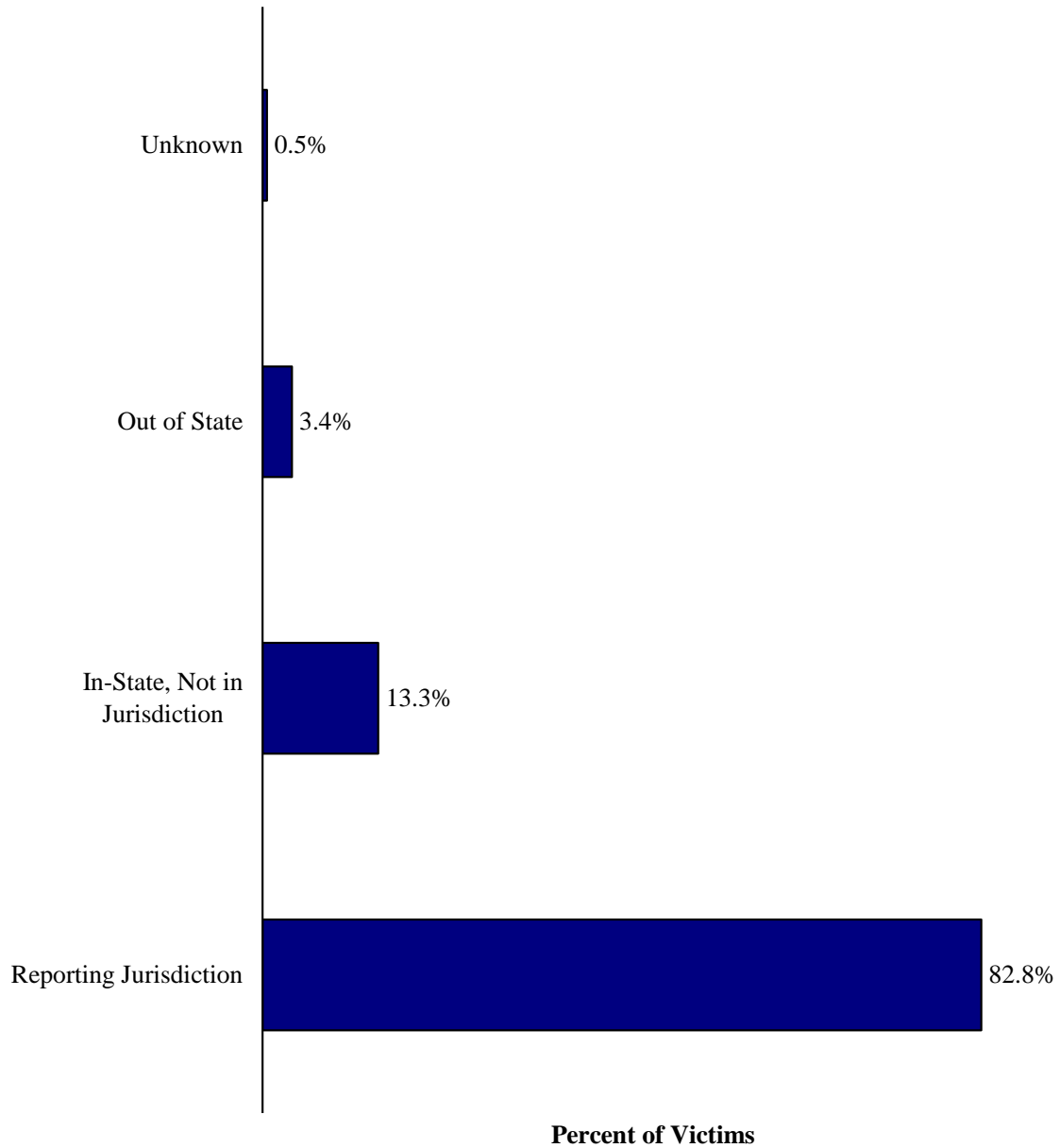

The most frequently reported type of victim to offender relationship among sexual violence victims involved a relationship where the victim and offender knew one another, but there was no family, marital or romantic relationship.

VICTIM TO OFFENDER RELATIONSHIP: SCIBRS records the relationship between the victim and offender into one of 26 categories. For the purpose of this report, six categories encompassing victim/offender relationships were constructed: family, known, marital, romantic, stranger and relationship unknown. . The easiest way to understand the victim to offender relationship is to substitute the phrase, “the victim was” followed by the type of relationship; e.g., if the victim to offender relationship category is family, the victim was a family member of the offender.

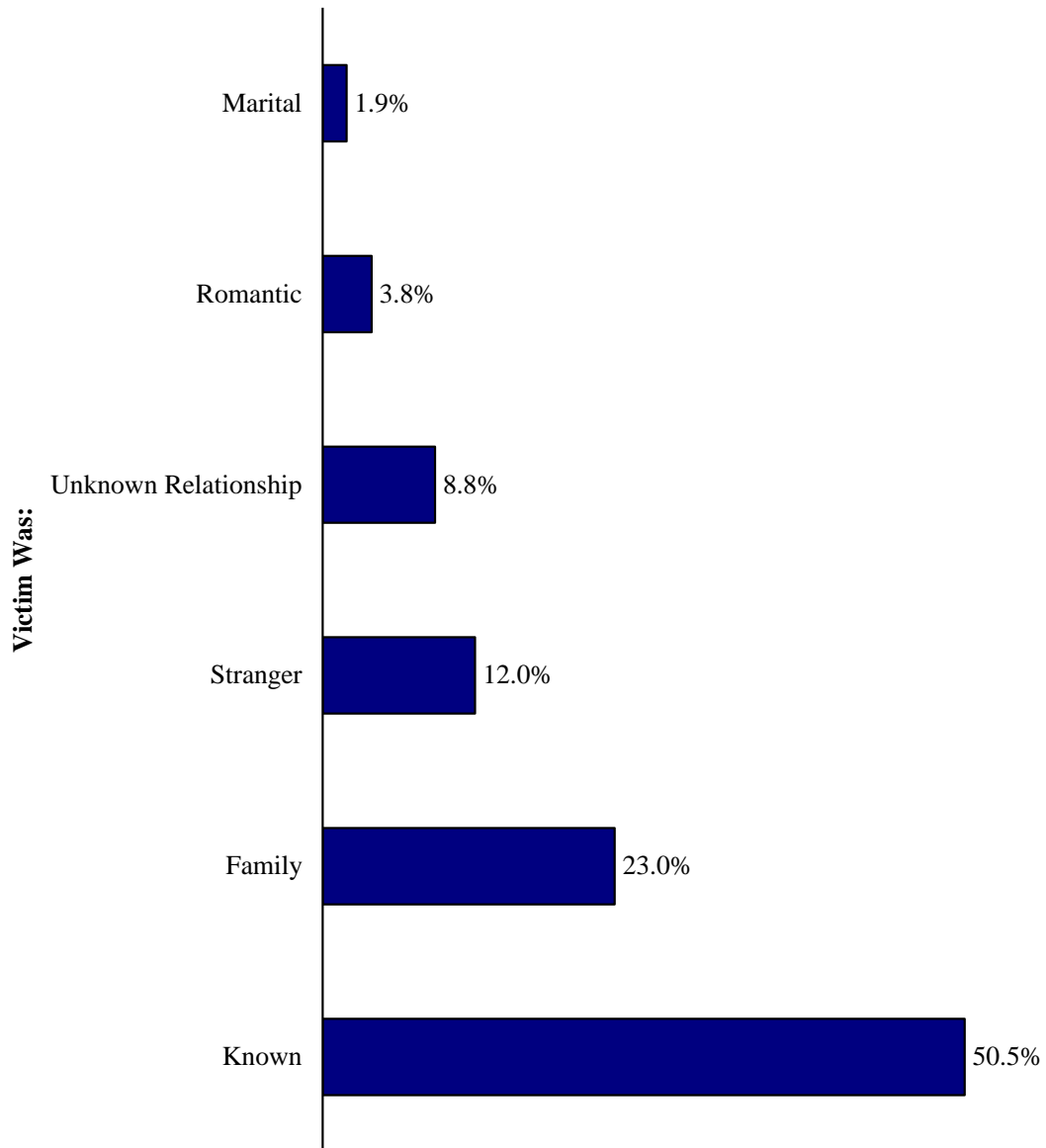

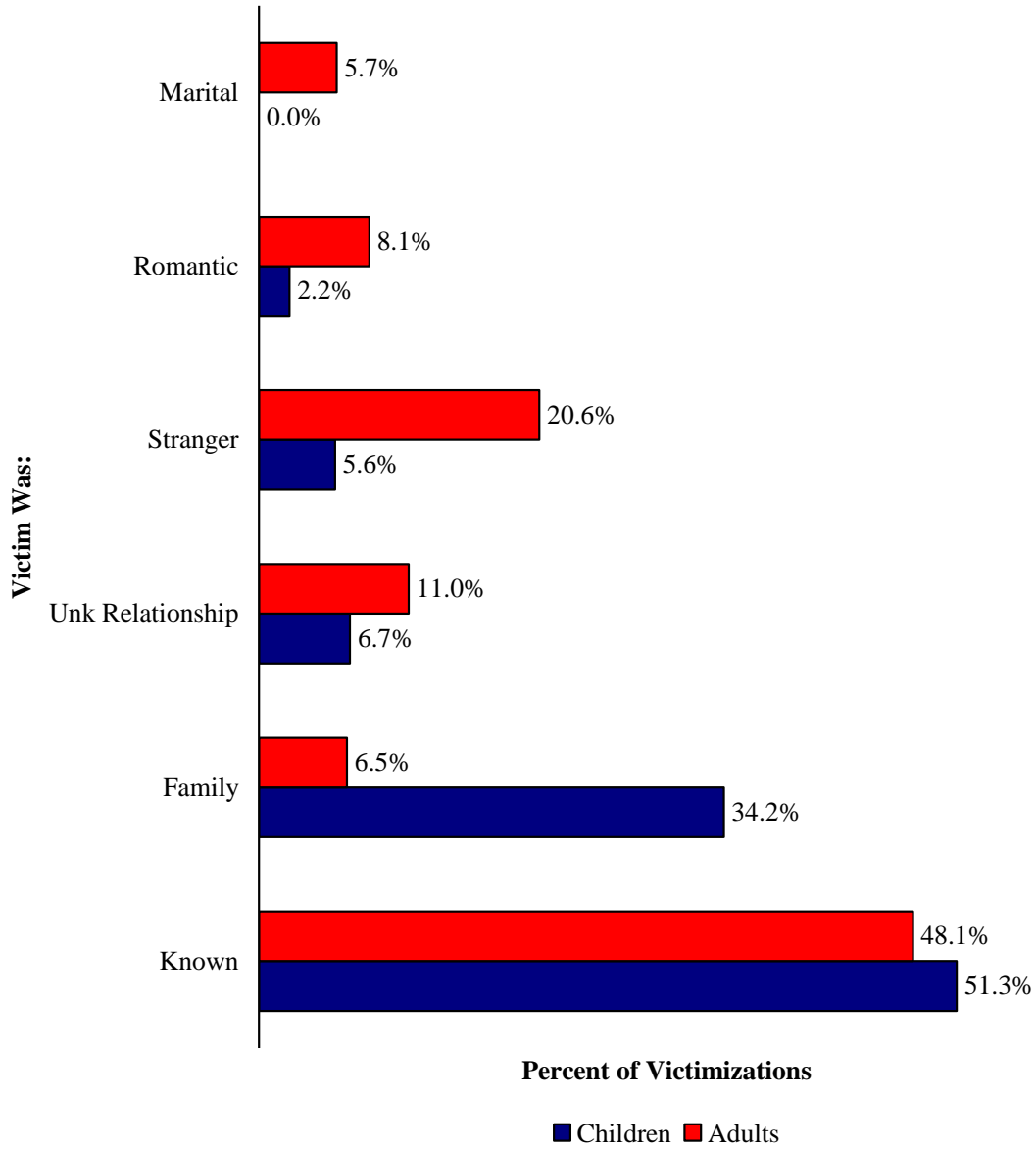

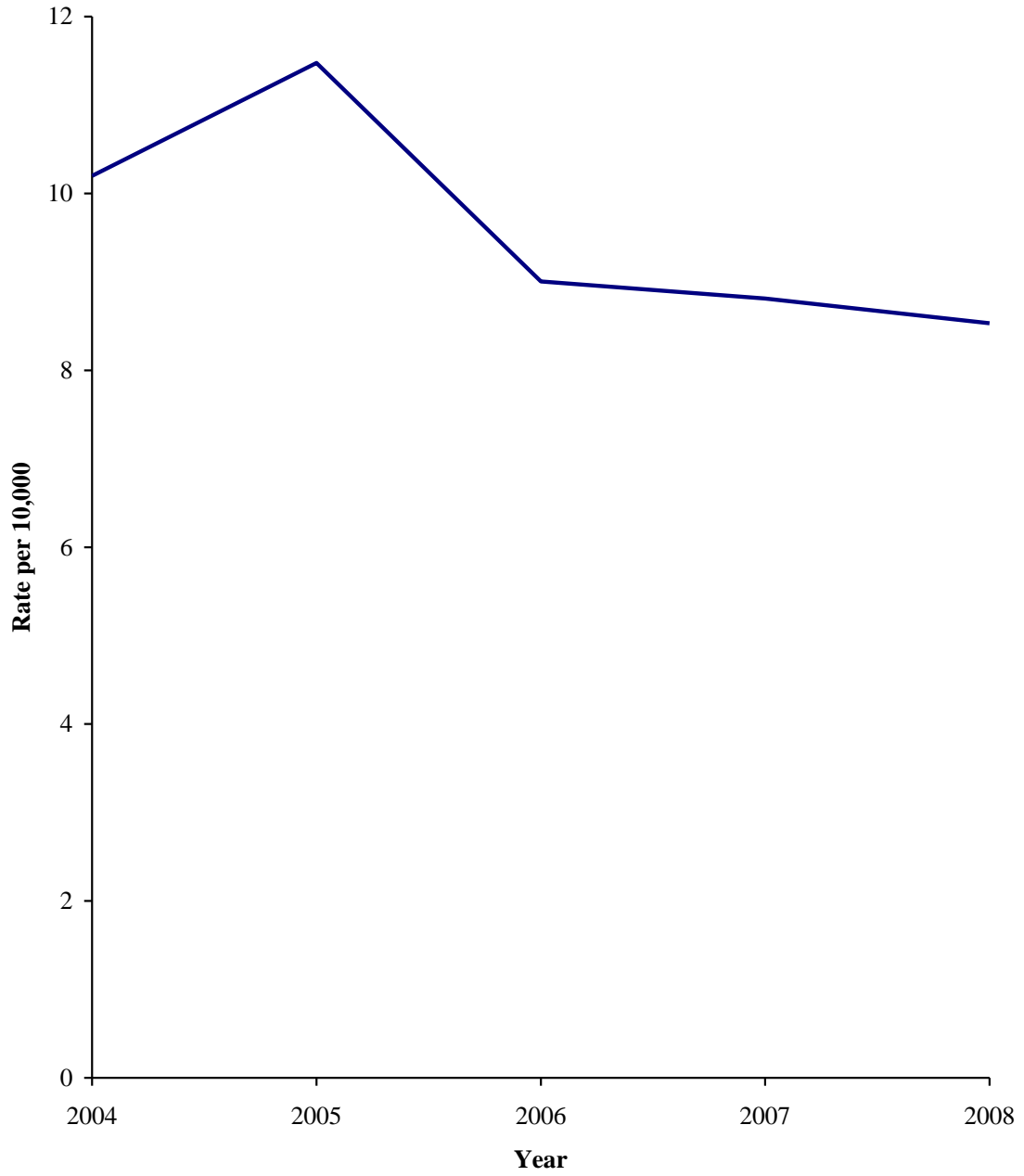

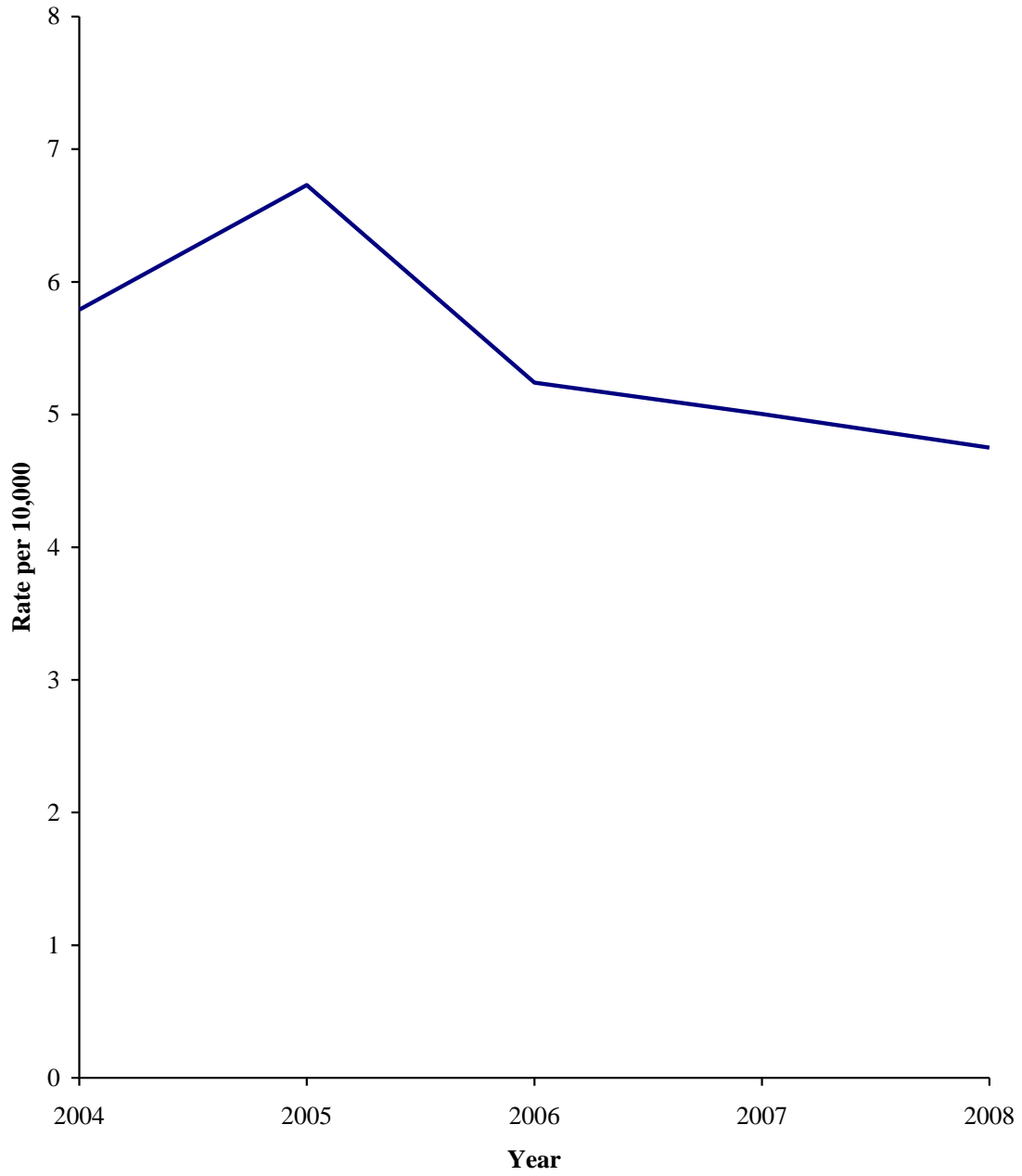

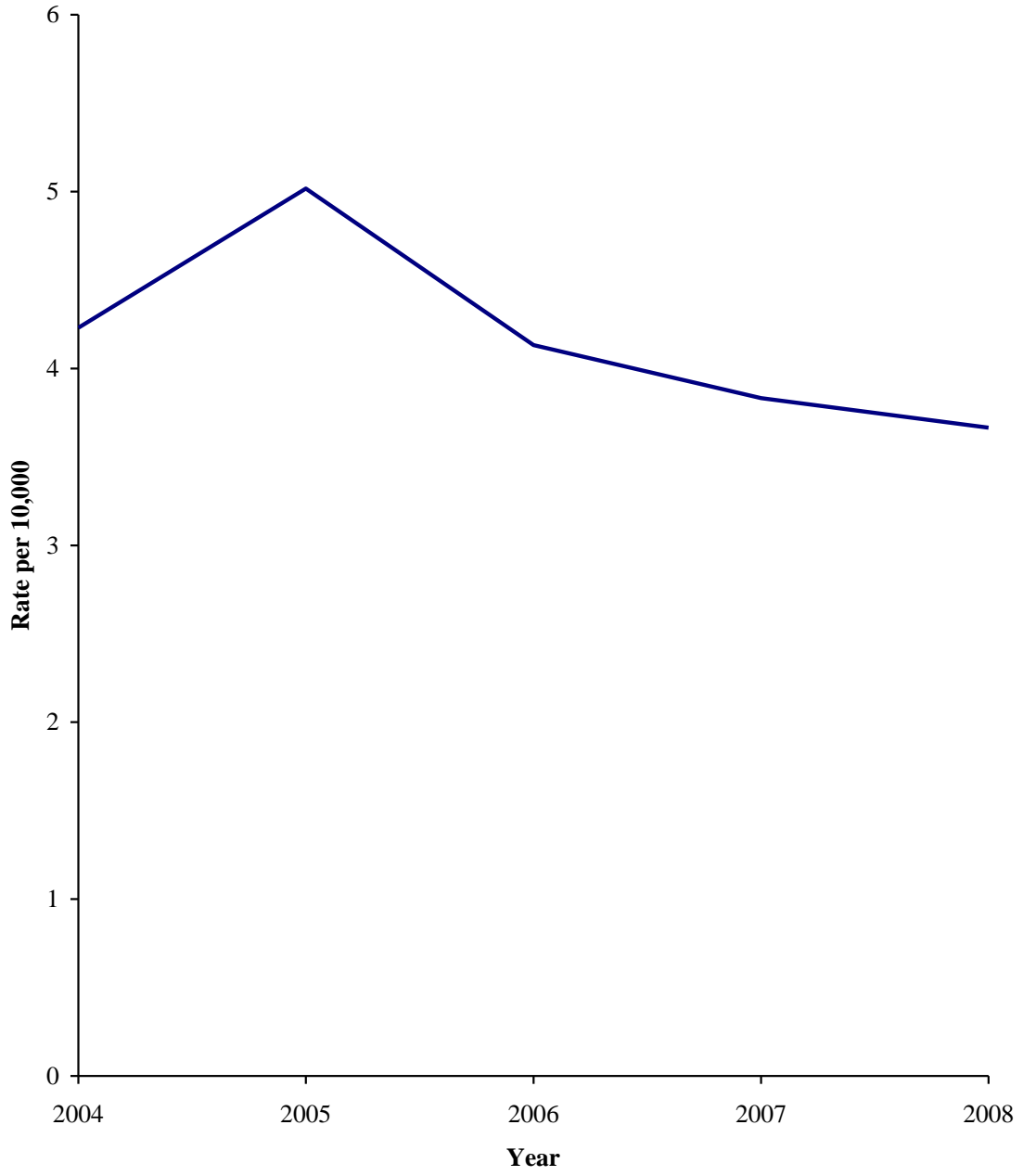

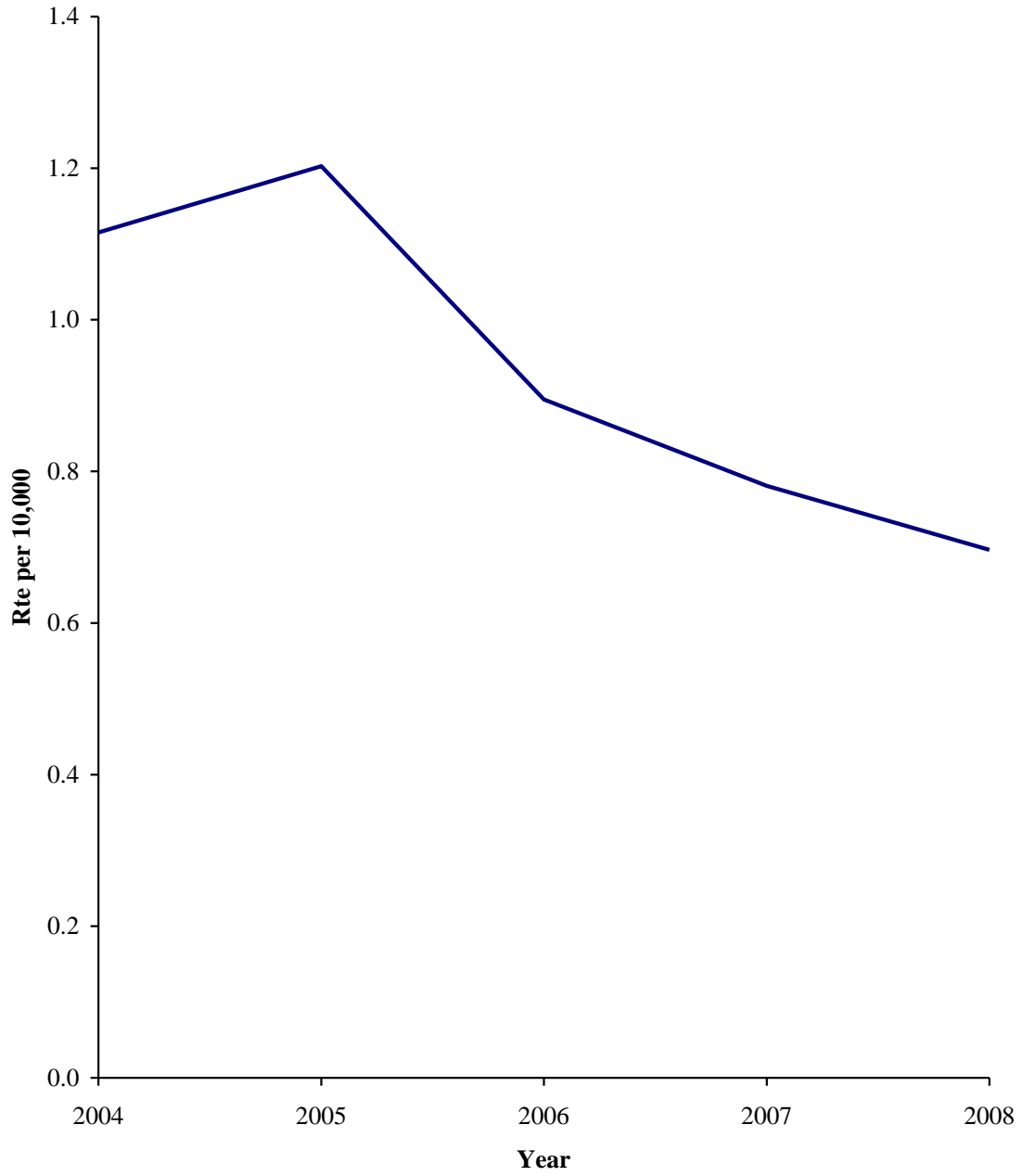

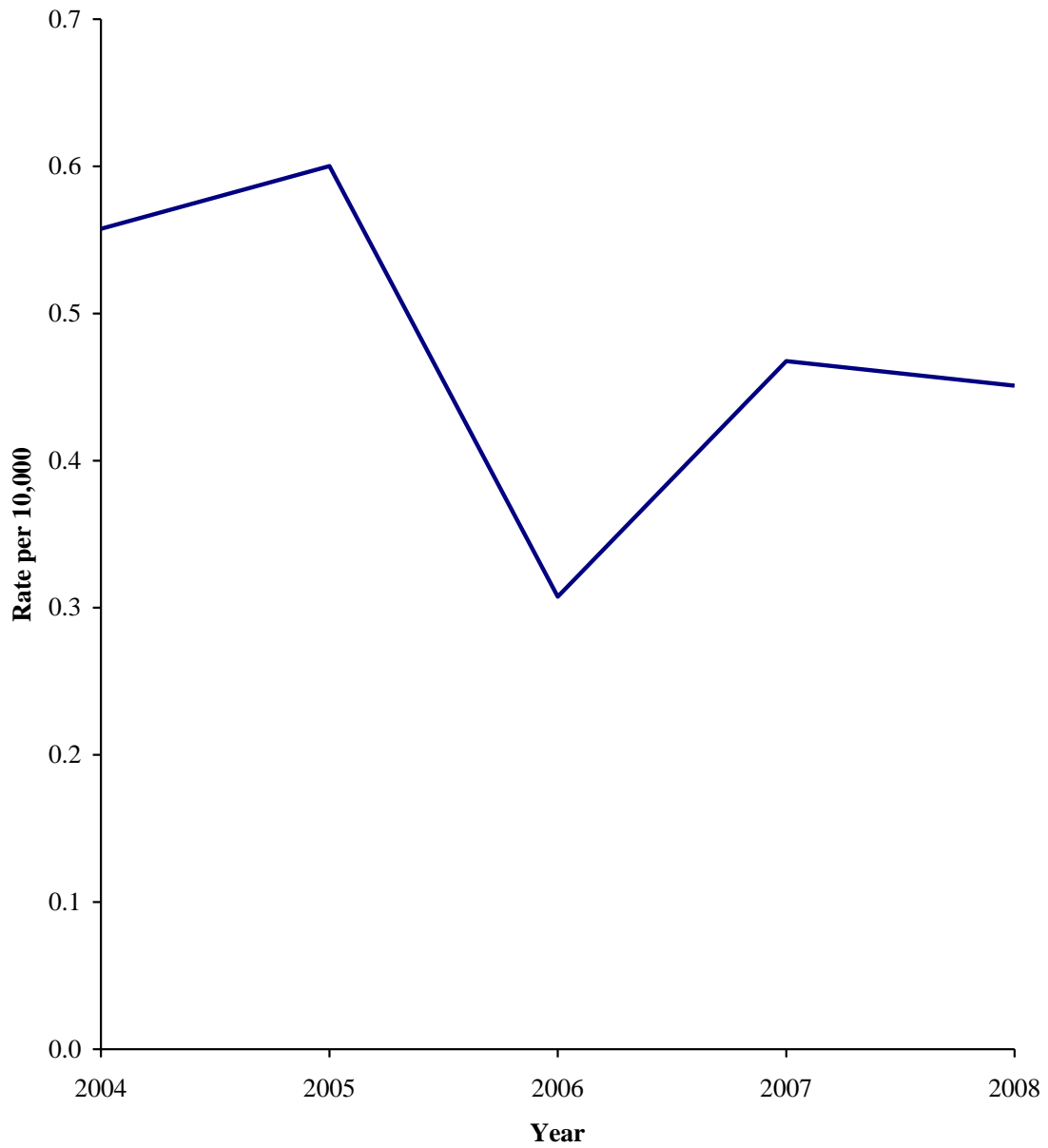

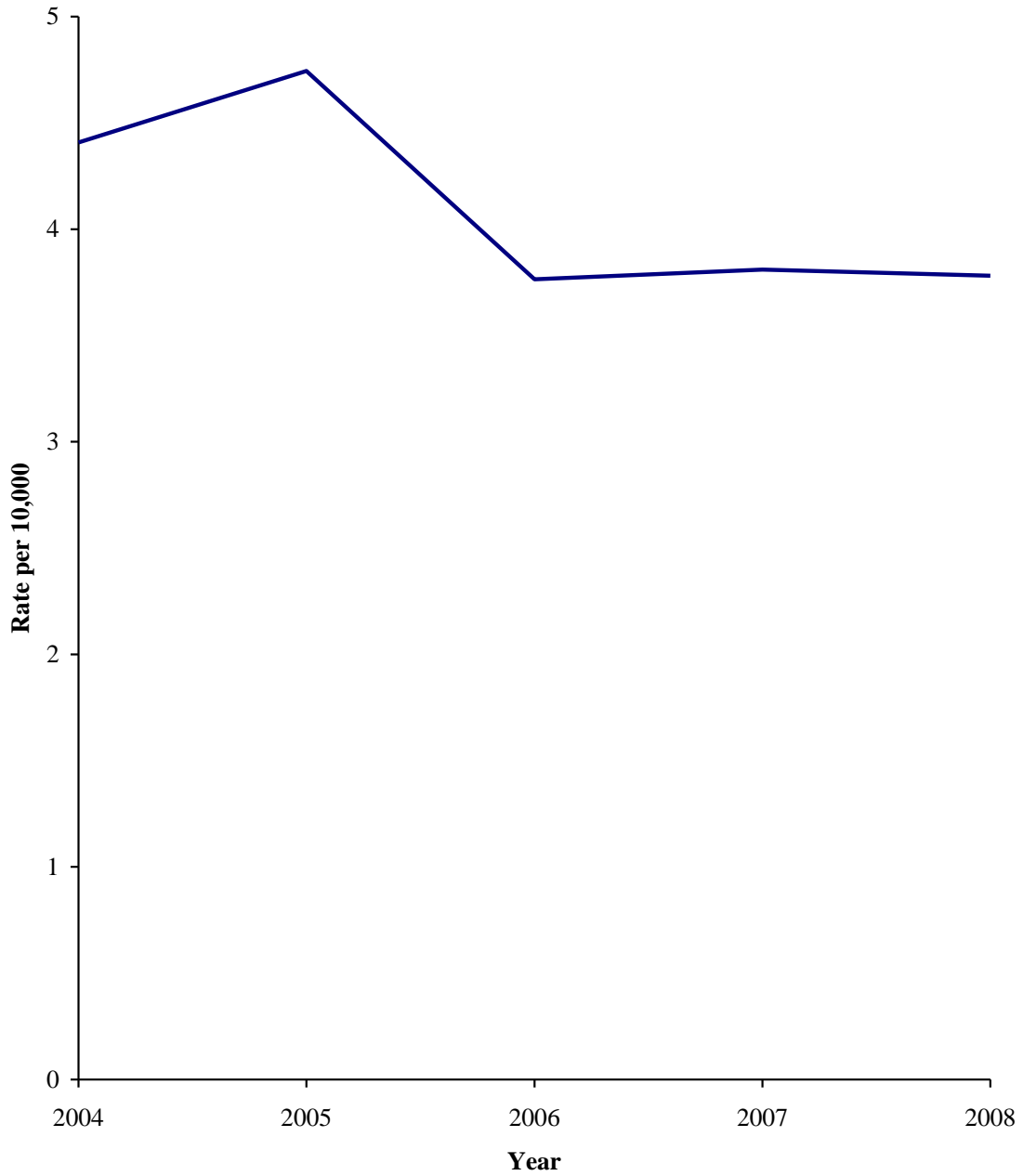

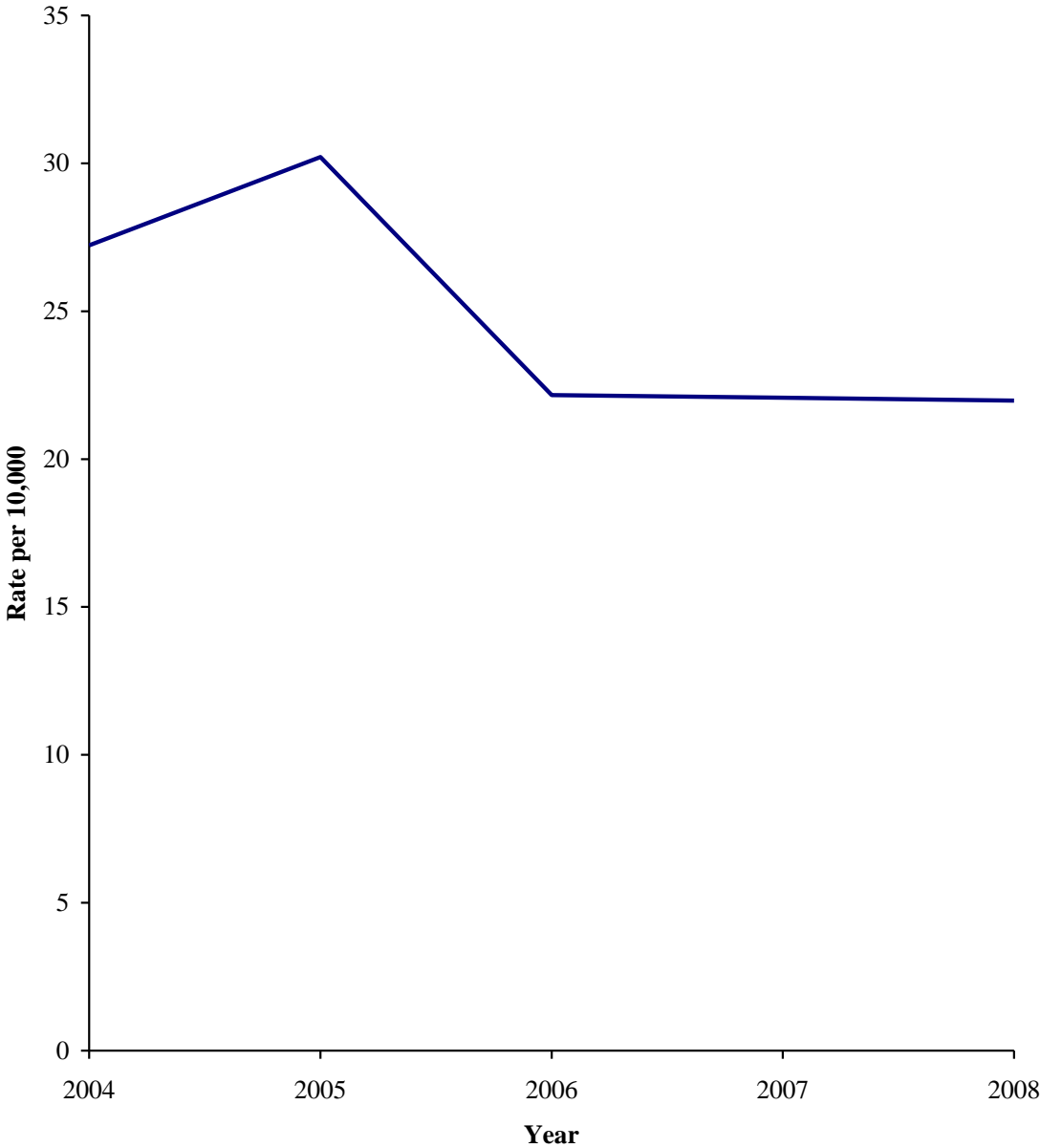

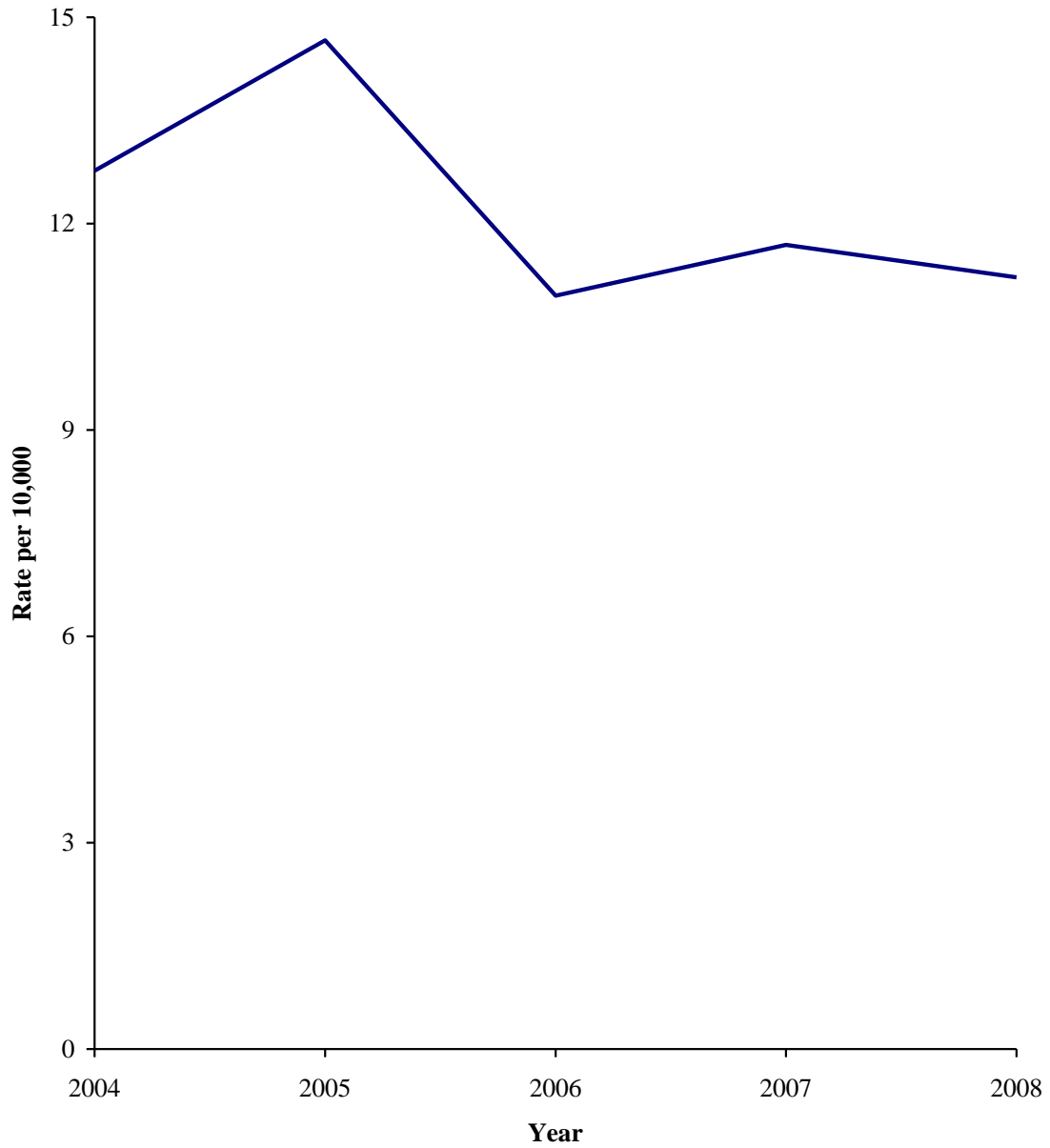

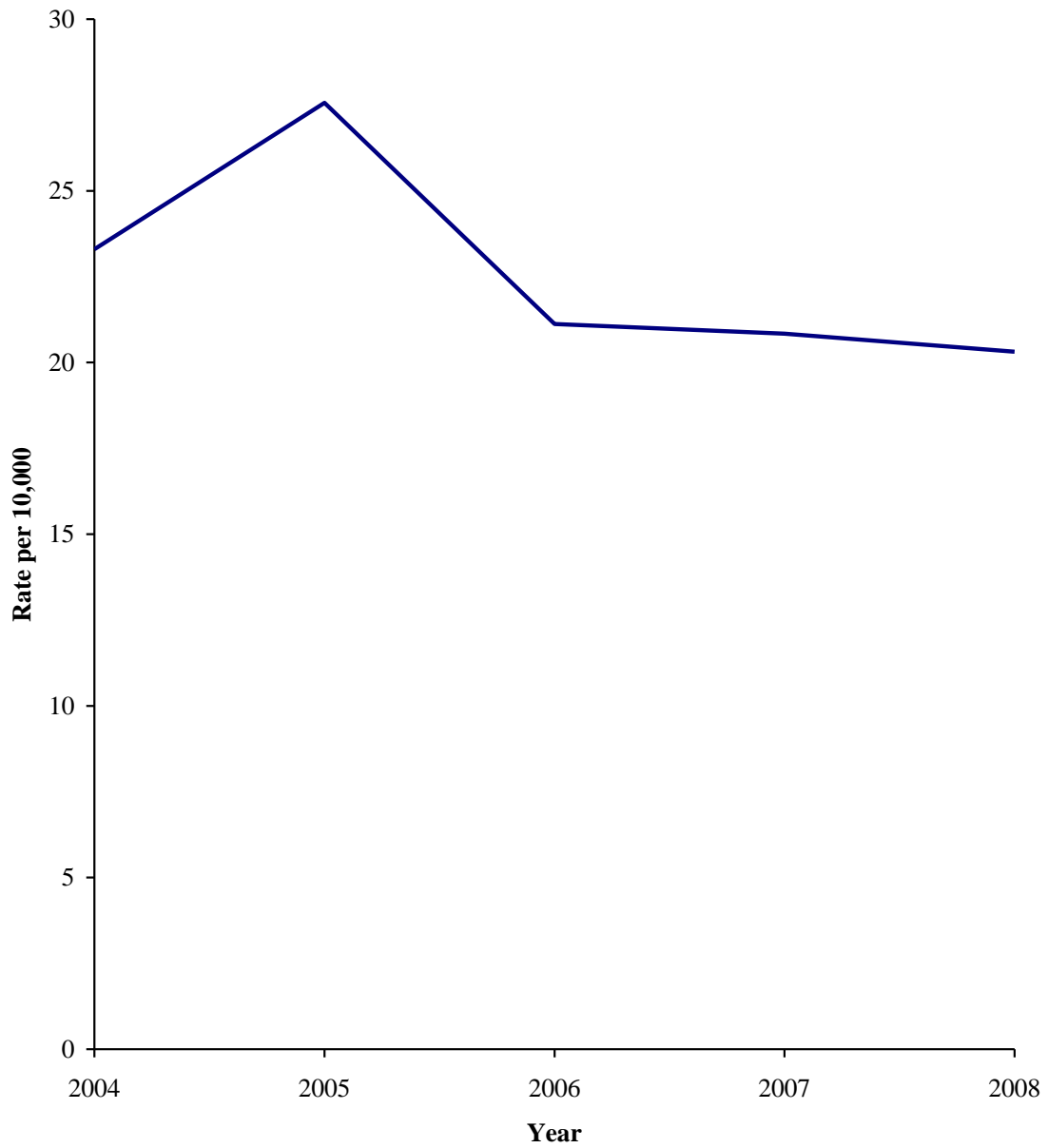

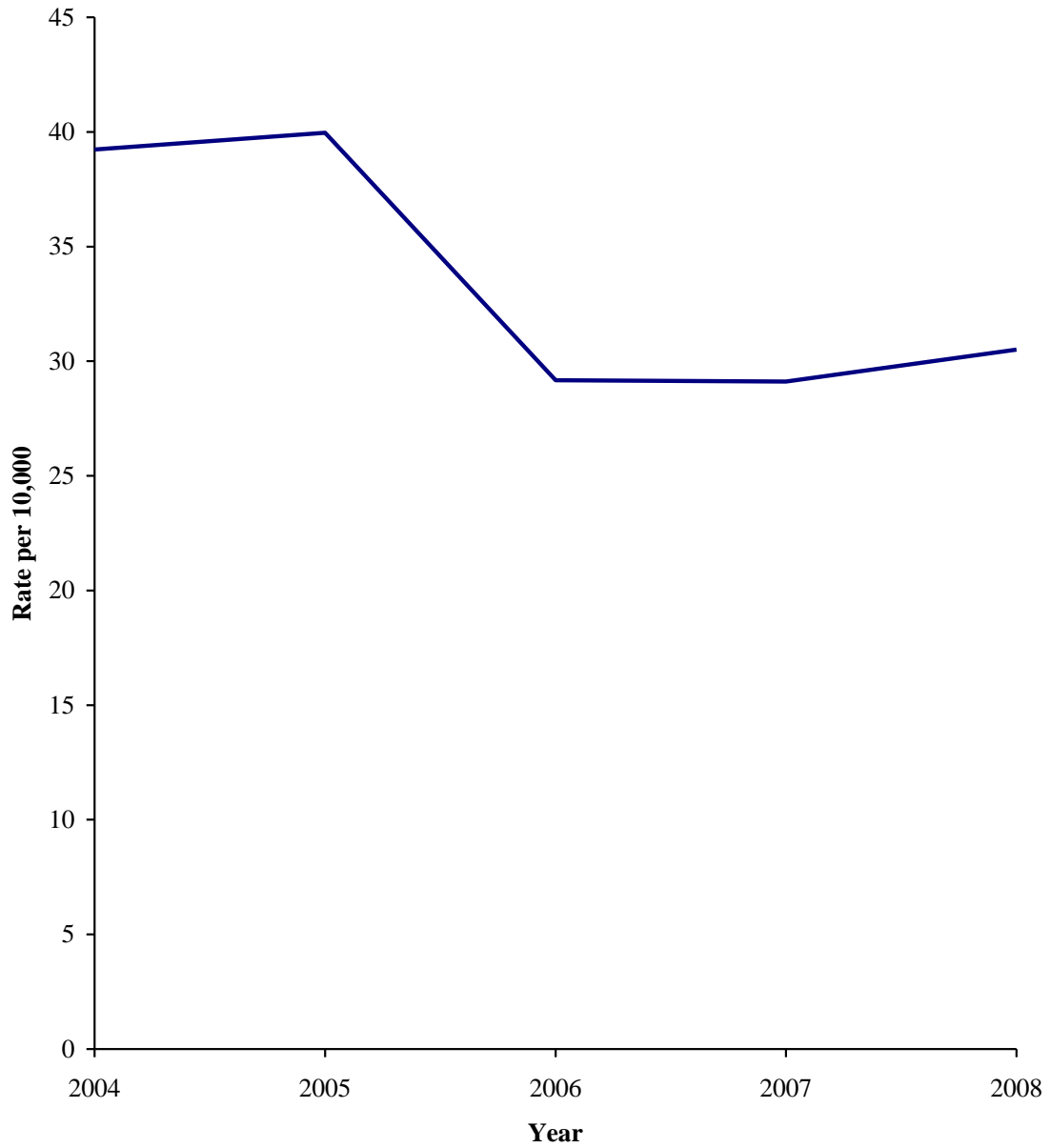

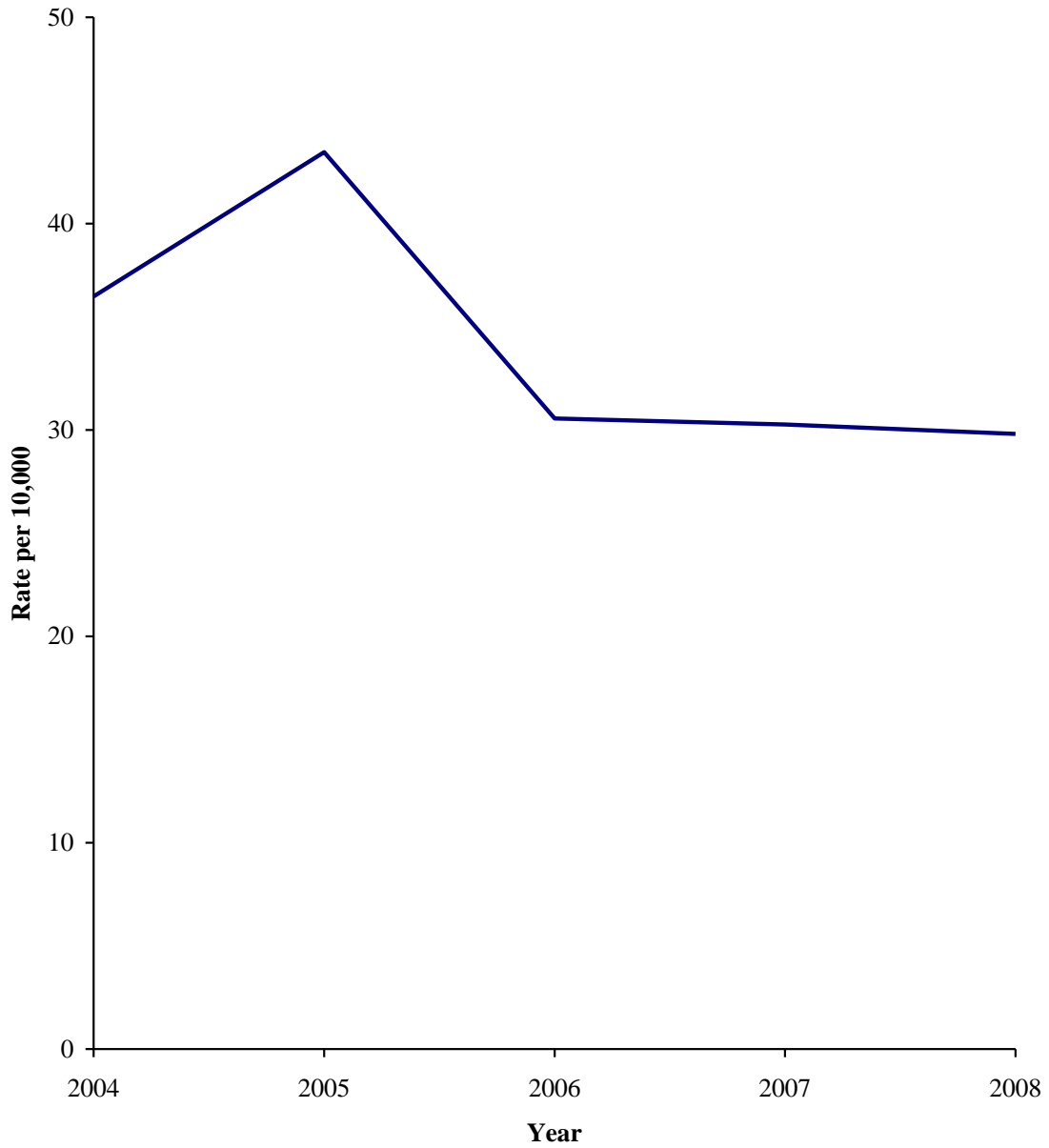

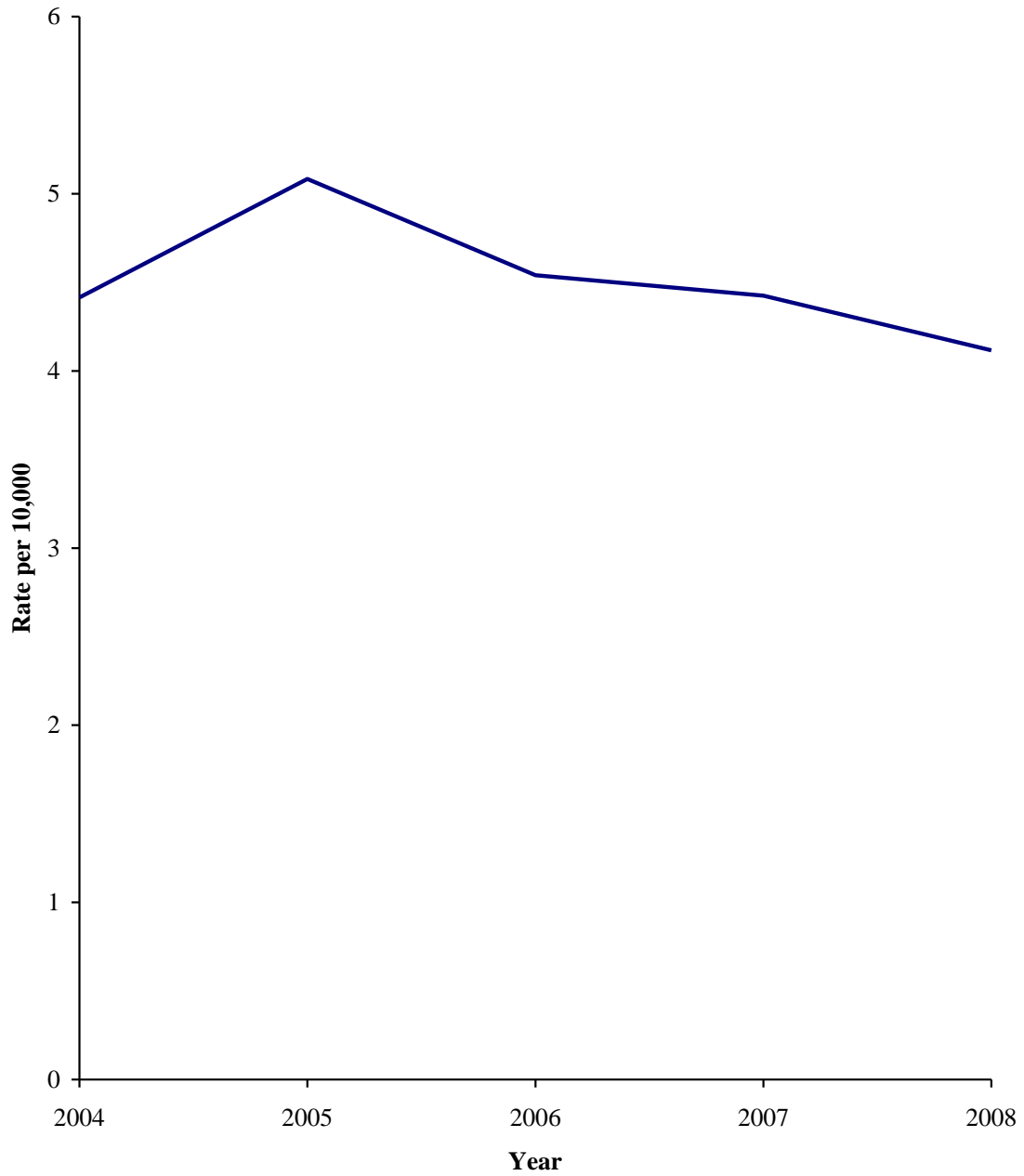

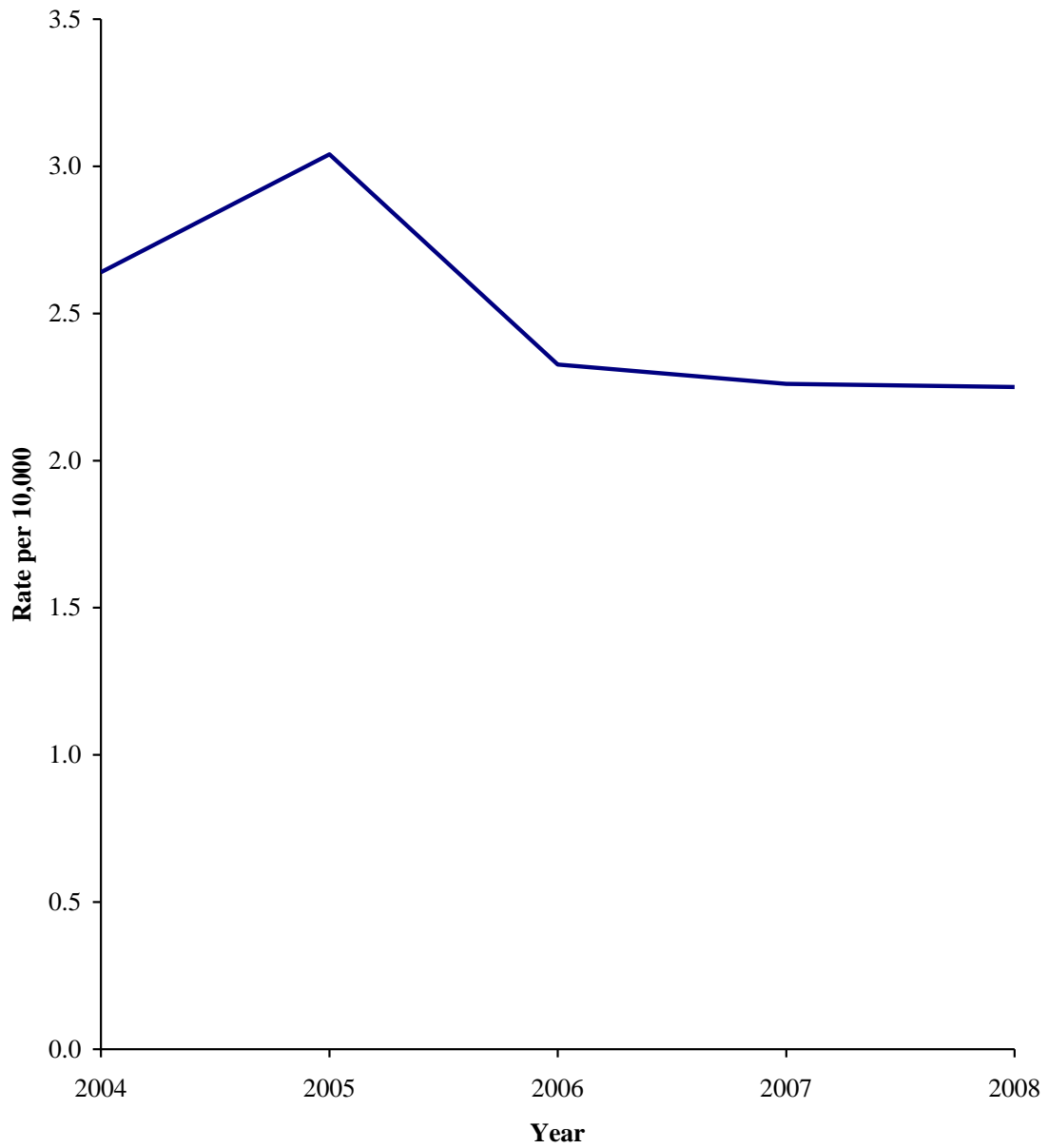

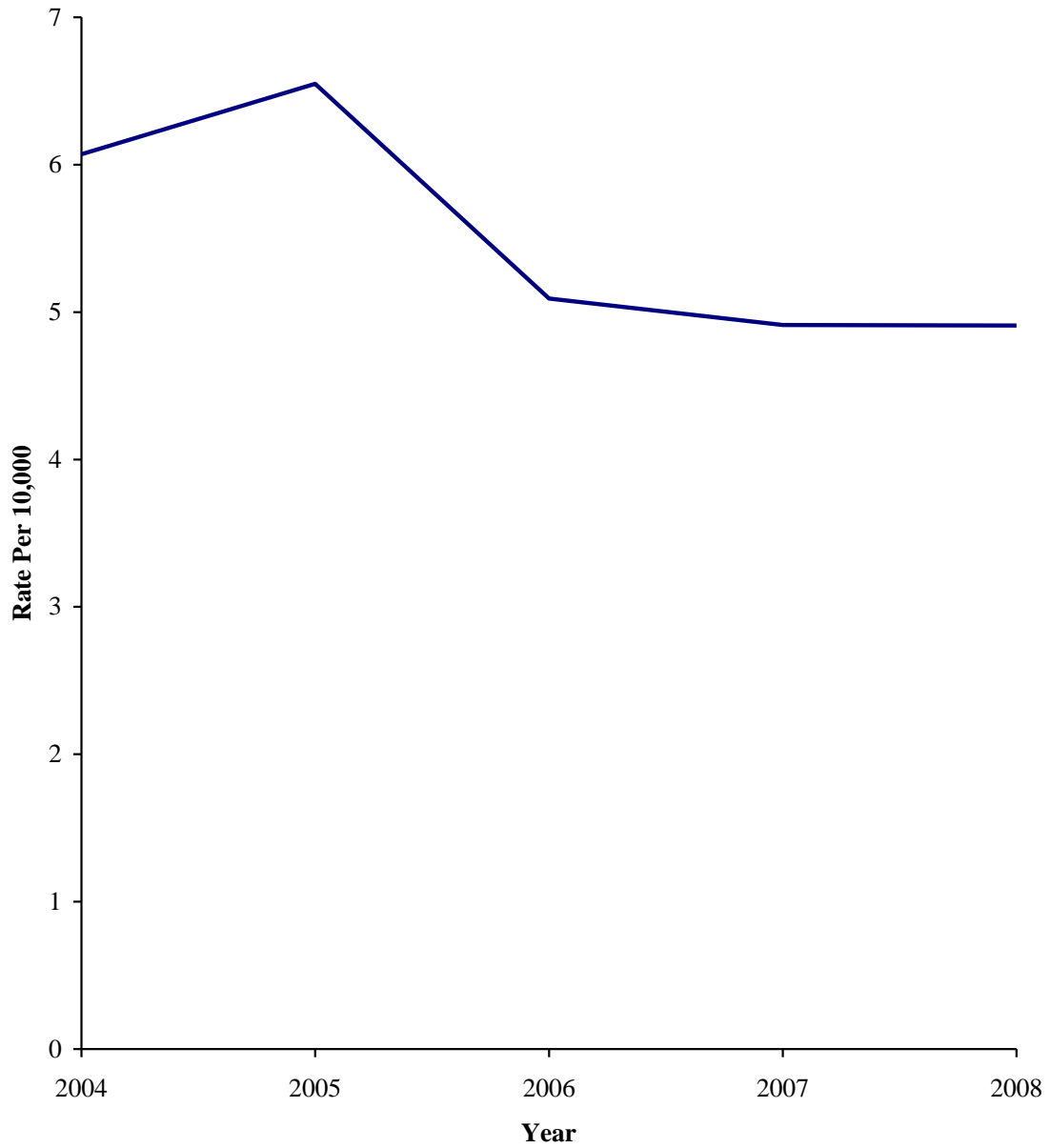

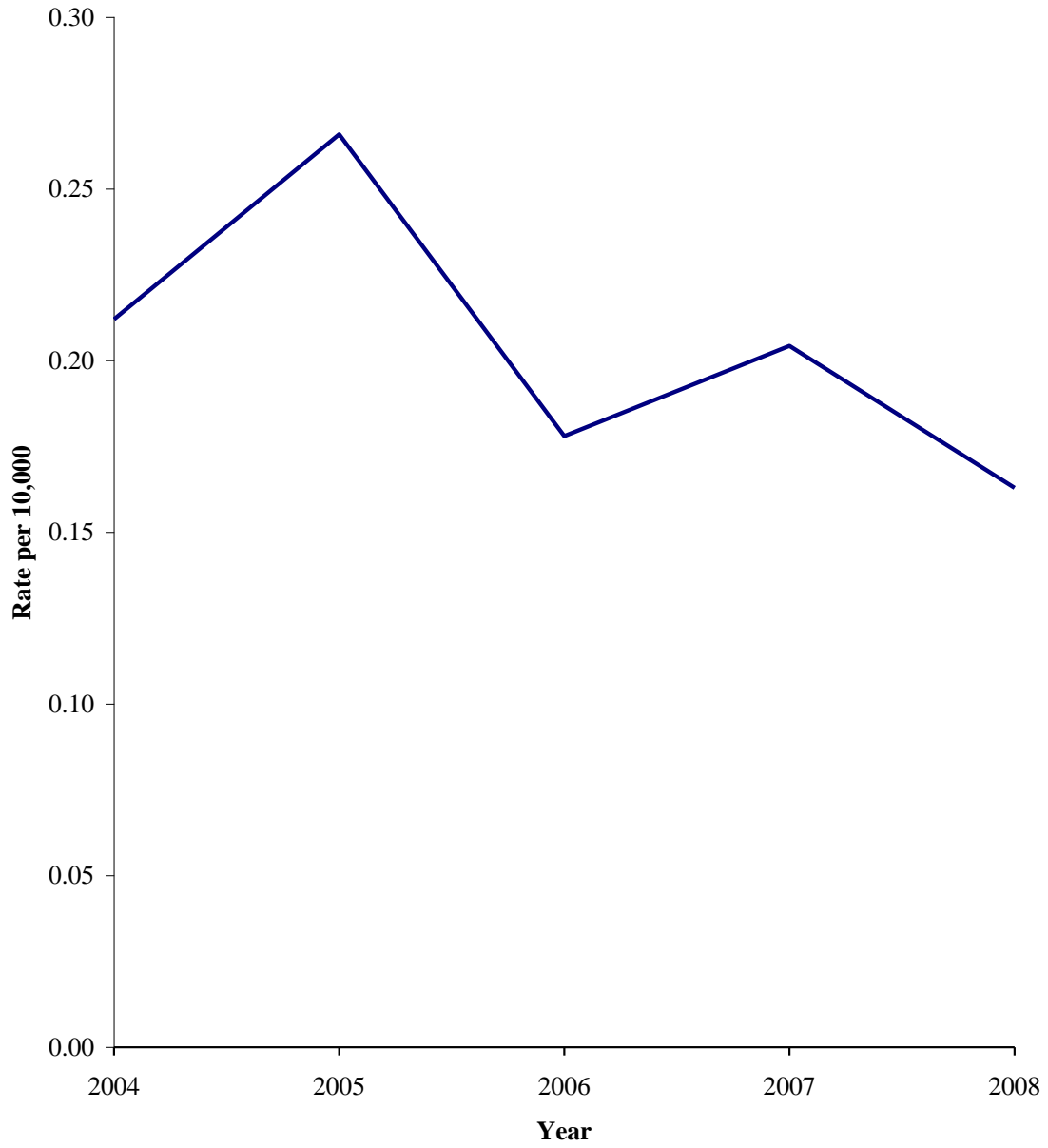

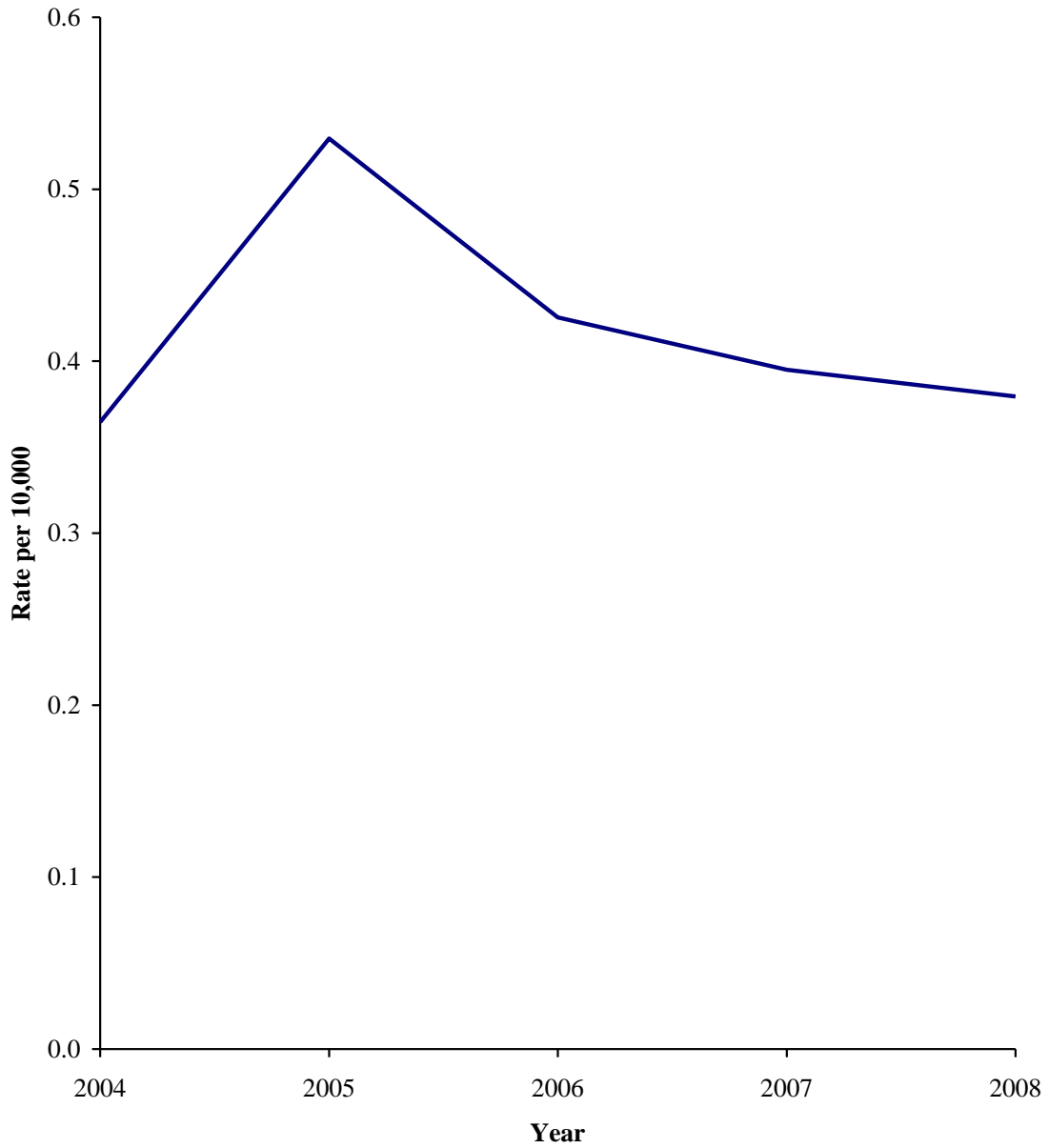

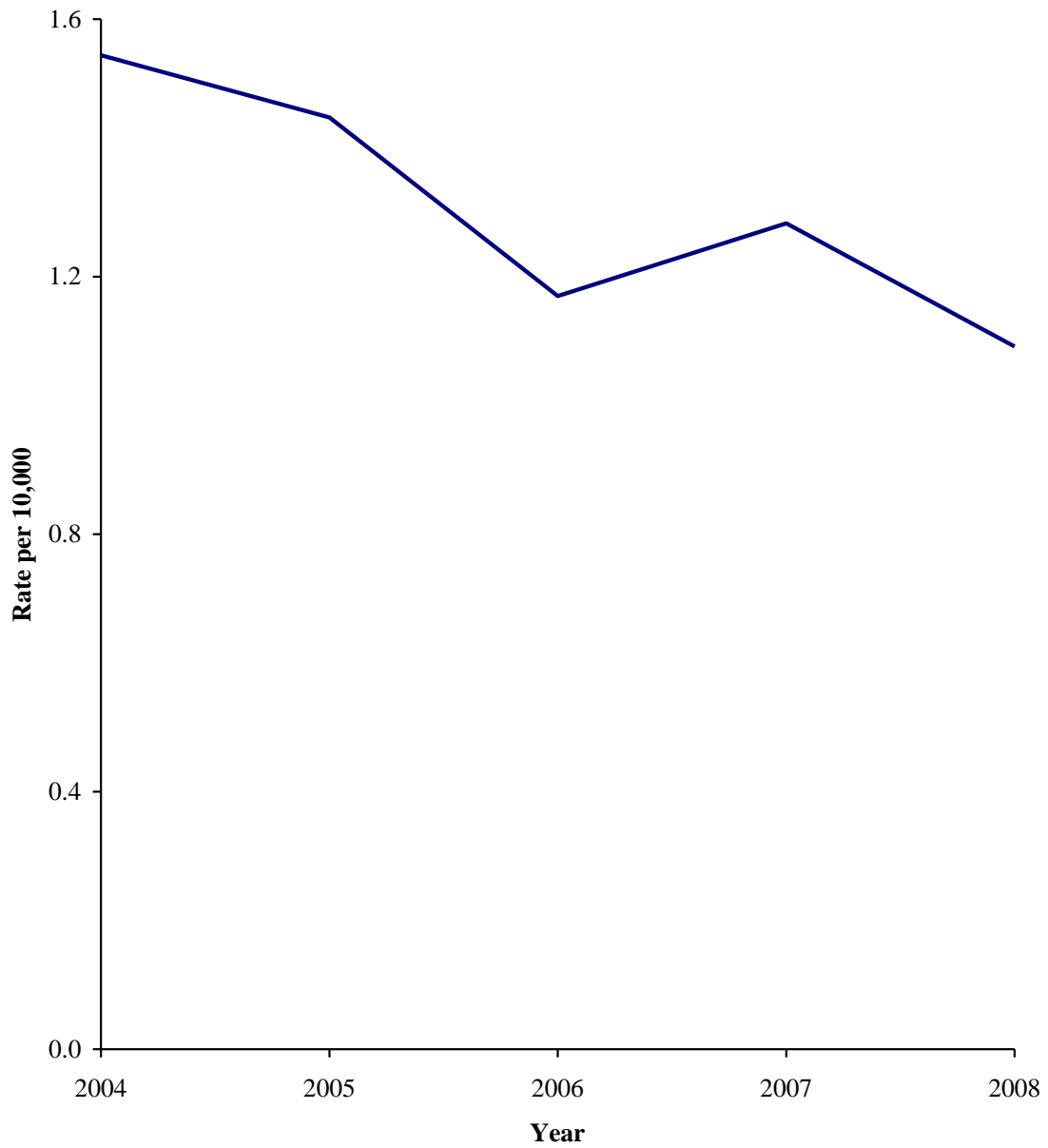

SUMMARY Of FINDINGS

Nearly all the statewide indicators of sexual violence victimization trends demonstrated a decline from 2004 through 2008. Overall, the number of sexual violence victims decreased 10.7%, while the sexual violence victimization rate per 10,000 decreased 16.1% over the five year period. The invasive sexual violence victimization rate decreased (17.2%), the rape victimization rate decreased (11.9%), the forcible sodomy victimization rate decreased (37.5%); the sexual assault with an object victimization rate decreased (19.6%) as did the forcible fondling victimization rate (14.3%). Similarly, sexual violence victimization rates against children and adults decreased 19.1% and 6.8% respectively from 2004 through 2008. Following the same pattern over the five year time period, sexual violence victimization rates involving family victim/offender relationships decreased (6.8%), as did the sexual violence victimization rates involving marital victim/offender relationships (23.8%), sexual violence victimization involving victim/offender relationships where the victim and offender knew but did not have a family, marital or romantic relationship (17%), and sexual violence victimization involving strangers (18.1%). The lone exception to this pattern of decreasing sexual victimization rates was the sexual victimization rate involving romantic victim/offender relationships, which increased 5.6% from 2004 through 2008. It is important to note that romantic victim/offender relationships accounted for less than 4% of sexual violence victimization.

Demographically, there were noteworthy differences in sexual violence victimization based on victim age, race, sex and ethnicity. Most (62.6%) sexual violence victims were White; however the sexual violence victimization rate among Non-Whites was 10.9% higher than the victimization rate among Whites. Hispanics comprised only 3% of sexual violence victims and the sexual violence victimization rate among Non-Hispanics was 21.5% higher than the victimization rate among Hispanics. Age and sex proved to be two especially important demographic factors, crucial to an understanding of patterns of violent sexual victimization. Children (17 years of age or younger) accounted for 63.7% of sexual violence victims and the sexual violence victimization rate among children was 5.5 times the sexual violence victimization rate among adults. Women and girls accounted for 86.1% of sexual violence victims, while men and boys accounted for 13.9% of victims. The sexual violence victimization rate among females was six times the victimization rate among males. Girls from 15 to 17 years old experienced the highest sexual violence victimization rate, 63.7 per 10,000, of any sex/age group, closely followed by girls from 10 to 14 years old who had a victimization rate of 60.4. The next highest victimization rates were among girls 5 to 9 years of age with a sexual violence victimization rate of 31.4 and women from 18 to 24 years of age with a rate of 28.2 per 10,000. As a group, girls had a sexual violence victimization rate of 41.3 per 10,000. By way of comparison, the sexual violence victimization rate among boys was 9.1, among women the sexual violence victimization rate was 8.6 and among men the sexual violence victimization rate was 0.4 per 10,000. While girls and young adult women were at the highest risk of sexual violence, it is important to note that boys, particularly those younger than 15 years of age, also constituted a vulnerable population.

Temporal patterns of sexual violence victimization also varied with victim age. Adult victimization occurred at increasing levels throughout the evening hours, peaked at midnight and gradually declined during the early morning hours. However, violent sexual victimization among children had a quite different time of day pattern. Among children, violent sexual victimization was reported at several peak times: midnight, eight o'clock in the morning, noon and three o'clock in the afternoon, then dropped off, sometimes dramatically, from those peak times. It seems likely that the daytime peaks of child victimization might be related to behavior associated with school attendance such as leaving home and going to school, eating lunch and/or participating in other activities during the lunch-hour and returning home from school.

Age also had an influence on victimization patterns related to victim/offender relationships. While both children and adults were most likely to have been victimized by someone they knew but with whom they had no family, marital or romantic relationship, there were other important age related differences. However, adults were victimized most often by someone they knew or a by strangers and much less frequently by family members. Children were victimized most often by someone they knew or by a family member and much less frequently by strangers. While "stranger danger" cannot be dismissed out of hand as a serious issue for children, the findings indicated that sexual victimization by a stranger was more of a danger for adults than for children.

Nearly all measures of sexual violence victimization declined over the five year period. The single exception to that pattern of declining indicators was the increase in sexual violence within romantic victim/offender relationships. Although sexual violence within romantic victim/offender relationships represents a small portion of the entirety of sexual victimization, interestingly, an increase in domestic violence within romantic victim/offender relationships during the same time period (see *The Rule of Thumb: A Five Year Overview of Domestic Violence in South Carolina 2004 - 2008*, pages 62 – 63 and 231, <http://www.scdps.org/ojp/statistics.asp>) was also observed. While the underlying reasons behind the increase in sexual and domestic violence in romantic victim/offender relationships could not be determined from the data, it is clear that violence involving romantic/dating partners is a problem which bears ongoing scrutiny. The difference between children and adults in terms of the relatively high degree of child victimization by family members and relatively infrequent victimization by strangers has implications for training and prevention efforts. Similarly, the varying time of day patterns of violent sexual victimization against children compared to adults points to the need for a more nuanced appreciation of those differences, particularly as they relate to primary prevention efforts. Finally, the findings demonstrate the degree to which children, especially girls, are disproportionately at risk of sexual violence.
